AN ACT

- 1 Establishing a task force on the opioid abuse epidemic's impact
- on children and providing for powers and duties of the task
- 3 force.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Opioid Abuse
- 8 Child Impact Task Force Act.
- 9 Section 2. Declaration of policy.
- 10 The General Assembly finds and declares as follows:
- 11 (1) This Commonwealth is one of the states which has
- 12 been hardest hit by an epidemic of heroin and prescription
- opioid abuse and addiction that is plaguing American society.
- 14 (2) One of the more tragic consequences of this epidemic
- is the devastating impact it has had and continues to have on
- 16 infants and children.
- 17 (3) Newborns are suffering through withdrawal from

- opioids because of prenatal exposure to these drugs.
- 2 (4) Fatalities and near fatalities of infants and young
- 3 children have been linked to parental substance abuse.
- 4 (5) Cases of child abuse and neglect linked to parental
- 5 substance abuse are increasing, as are the number of children
- 6 being removed from their homes and placed in protective
- 7 custody because of their parents' drug addiction.
- 8 (6) The Commonwealth has a responsibility to protect its
- 9 residents, especially children.
- 10 Section 3. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Task force." The task force established in section 4.
- 15 Section 4. Establishment.
- 16 A task force on the opioid abuse epidemic's impact on
- 17 children is established. The task force shall focus on improving
- 18 the safety, well-being and permanency of substance-exposed
- 19 infants and other young children affected by their parents'
- 20 substance abuse disorders.
- 21 Section 5. Responsibilities.
- 22 The task force is responsible for:
- 23 (1) Identifying strategies and making short-term and
- 24 long-term recommendations to prioritize the prevention of
- 25 substance-exposed infants.
- 26 (2) Improving outcomes for pregnant and parenting women
- 27 who are striving to recover from addiction.
- 28 (3) Promoting the health, safety and permanency of
- 29 substance-exposed infants and other young children at risk of
- 30 child abuse and neglect or placement in foster care due to

- 1 parental alcohol and drug use.
- 2 (4) Ensuring that the Commonwealth is compliant with the
- 3 Child Abuse Prevention and Treatment Act (Public Law 93-247,
- 4 42 U.S.C. § 5101 et seq.) related to identifying substance-
- 5 exposed infants and is developing multidisciplinary plans of
- 6 safe care for these infants.
- 7 Section 6. Members and meetings.
- 8 (a) Members.--The task force is comprised of the following
- 9 members:
- 10 (1) The Secretary of Human Services or a designee who
- shall be an employee of the Department of Human Services. The
- designee shall be appointed by the Secretary of Human
- 13 Services in writing, and a copy of the appointment shall be
- 14 submitted to the chairperson of the task force.
- 15 (2) The Secretary of Health or a designee who shall be
- an employee of the Department of Health. The designee shall
- 17 be appointed by the Secretary of Health in writing, and a
- copy of the appointment shall be submitted to the chairperson
- 19 of the task force.
- 20 (3) The Secretary of Drug and Alcohol Programs or a
- 21 designee who shall be an employee of the Department of Drug
- and Alcohol Programs. The designee shall be appointed by the
- 23 Secretary of Drug and Alcohol Programs in writing, and a copy
- of the appointment shall be submitted to the chairperson of
- 25 the task force.
- 26 (4) Three members appointed by the President pro tempore
- of the Senate, in consultation with the Majority Leader and
- the Minority Leader of the Senate. One member under this
- 29 paragraph may be a member of the Senate.
- 30 (5) Three members appointed by the Speaker of the House

- of Representatives, in consultation with the Majority Leader
- 2 and the Minority Leader of the House of Representatives. One
- member under this paragraph may be a member of the House of
- 4 Representatives.
- 5 (6) Four members appointed by the Governor.
- 6 (b) Qualifications.--Individuals appointed under subsection
- 7 (a) (4), (5) or (6) must possess professional experience and
- 8 expertise in:
- 9 (1) obstetric medicine;
- 10 (2) pediatric medicine;
- 11 (3) behavioral health treatment;
- 12 (4) early intervention programs;
- 13 (5) county children and youth agency services;
- 14 (6) child advocacy; or
- 15 (7) neonatal intensive care unit nursing.
- 16 (c) Chairperson. -- The Governor shall select the chairperson
- 17 of the task force.
- 18 (d) Appointment.--The members of the task force shall be
- 19 appointed within 25 days after the effective date of this
- 20 section.
- 21 (e) Quorum.--The physical presence of seven members
- 22 constitutes a quorum of the task force.
- 23 (f) Majority vote. -- An action of the task force shall be
- 24 authorized or ratified by a majority vote of its members.
- 25 (q) Meetings.--
- 26 (1) The task force shall meet as necessary but no fewer
- 27 than five times prior to November 30, 2021 DURING THE PERIOD <--
- 28 ENDING TWO MONTHS PRIOR TO THE ISSUANCE DATE OF THE REPORT.
- 29 The first meeting shall be convened within 45 days following
- 30 the effective date of this section.

- 1 (2) Additional meetings may be called by the chairperson
- 2 as necessary.
- 3 (3) The chairperson shall schedule a meeting upon
- 4 written request of eight members of the task force.
- 5 (4) A member not physically present may participate by
- 6 teleconference or video conference.
- 7 (h) Compensation. -- Members of the task force shall not
- 8 receive compensation but shall be reimbursed for reasonable and
- 9 necessary expenses incurred in service of the task force.
- 10 Section 7. Duties.
- 11 The task force has the following duties:
- 12 (1) To examine and analyze the existing practices,
- processes, procedures and laws relating to the diagnosis and
- 14 treatment of substance-exposed infants.
- 15 (2) To review and analyze the existing practices,
- processes, procedures and laws relating to the safety, well-
- being, permanency and placement of children at risk due to
- 18 their parents' substance abuse disorders.
- 19 (3) To hold public hearings for the taking of testimony
- and the requesting of documents.
- 21 (4) To make relevant recommendations for improving the
- safety, well-being and permanency of substance-exposed
- infants and other children adversely affected by their
- 24 parents' substance abuse disorders.
- 25 (5) To issue a report in accordance with section 10.
- 26 Section 8. Hearings.
- 27 The task force shall hold public hearings as necessary to
- 28 obtain the information required to conduct its review.
- 29 Section 9. Agency cooperation.
- 30 The Department of Human Services, the Department of Health

- 1 and the Joint State Government Commission shall cooperate to
- 2 provide administrative or other assistance to the task force.
- 3 Section 10. Reports.
- 4 (a) General rule. -- The task force shall prepare and submit,
- 5 by January 31, 2022 TWO MONTHS PRIOR TO THE EXPIRATION DATE OF <--
- 6 THIS ACT, a final report on its activities, findings and
- 7 recommendations to the Governor, the Senate and the House of
- 8 Representatives. The task force may file status reports and
- 9 updates with the Governor, the Senate and the House of
- 10 Representatives as it deems appropriate.
- 11 (b) Adoption of report. -- A report under this section shall
- 12 be adopted at a public meeting.
- 13 (c) Public record.--A report under this section shall be a < --
- 14 public record under the act of February 14, 2008 (P.L.6, No.3),
- 15 known as the Right to Know Law AVAILABLE TO THE PUBLIC. <--
- 16 Section 11. Expiration.
- 17 This act expires March 1, 2022 12 MONTHS AFTER THE EFFECTIVE <--
- 18 DATE OF THIS ACT.
- 19 Section 12. Effective date.
- This act shall take effect immediately.
