8	Section 1. Title 53 of the Pennsylvania Consolidated	
9	Statutes is amended by adding a section to read:	
10	§ 306. Businesses operated by minors.	
11	(a) Restrictions on BUSINESS licenses and permits	<
12	Notwithstanding any other provision of law:	
13	(1) a municipality or an agency of a municipality may	
14	not require a BUSINESS license for a business that is:	<
15	(i) operated on an occasional basis by a minor; and	
16	(ii) located a sufficient distance, as determined by	_
17	the municipality, from a commercial entity required to	
18	obtain a BUSINESS license from the municipality or an	<

Τ	agency of the municipality to prevent the minor's
2	business from becoming a direct economic competitor of
3	the commercial entity.
4	(2) A municipality may not prohibit a business operated
5	by a minor from operating in a primarily residential zone or
6	unzoned area in the municipality.
7	(b) Construction Nothing in this section may be construed
8	to prohibit a municipality from enacting and enforcing local
9	laws relating to the manner in which a business may be operated
10	by a minor, with the exception of a requirement that the minor
11	obtain a permit or BUSINESS license prior to operating the
12	business.
13	(c) Definitions As used in this section, the following
14	words and phrases shall have the meanings given to them in this
15	subsection unless the context clearly indicates otherwise:
16	"Business."
17	(1) An enterprise that is:
18	(i) Exclusively owned by one or more minors
19	receiving not more than \$10,000 \$5,000 in net proceeds <
20	per year from the the enterprise UNLESS THE ENTERPRISE IS <
21	CREATED FOR A CHARITABLE PURPOSE.
22	(ii) Carried on for the purpose of gain or economic
23	<pre>profit.</pre>
24	(2) The term does not include:
25	(i) An act of an employee rendering services to an
26	<pre>employer.</pre>
27	(ii) An enterprise organized as a form of for-profit
28	corporation, limited liability partnership or company
29	under the provisions of 15 Pa.C.S. (relating to

- 7 "Municipality." A county, city, borough, incorporated town,
- 8 township or home rule municipality.
- 9 "Occasional basis." A business that does not operate more
- 10 than 84 days in a calendar year.

- 12 § 5115. Businesses operated by minors.
- 13 <u>(a) Restrictions on licenses.--Notwithstanding any other</u>
- 14 provision of law, an association or an agency of an association

- 3 "License." A license or permit required by an association to
- 4 temporarily or permanently offer sale of goods or provision of
- 5 <u>services or otherwise operate an enterprise in the municipality</u>
- 6 <u>in which the association is located.</u>
- 7 "Minor." A person under 18 years of age.
- 8 "Occasional basis." A business that does not operate more
- 9 <u>than 84 days in a calendar year.</u>
- 10 Section 3. This act shall take effect in 60 days.
