Amending Title 51 (Military Affairs) of the Pennsylvania Consolidated Statutes, in National Guard Youth Challenge 2 Program, further providing for definitions and for 3 administration, establishing the Keystone State Challenge Academy Fund ACCOUNT and further providing for report and for <--5 audit required. 6 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 9 Section 1. Section 9801 of Title 51 of the Pennsylvania 10 Consolidated Statutes is amended by adding a definition to read: § 9801. Definitions. 11 12 The following words and phrases when used in this chapter 13 shall have the meanings given to them in this section unless the context clearly indicates otherwise: 14 "Fund." "ACCOUNT." The Keystone State Challenge Academy Fund_<--15 16 ACCOUNT established under section 9807 (relating to Keystone 17 State Challenge Academy Fund ACCOUNT). <--* * * 18

Section 2. Sections 9806, 9807, 9810 and 9811 of Title 51

- 1 are amended to read:
- 2 § 9806. Administration.
- 3 (a) Staffing. -- Subject to 32 U.S.C. § 509 (relating to
- 4 National Guard Youth Challenge Program of opportunities for
- 5 civilian youth) and its implementing regulations and applicable
- 6 agreements, the program shall be staffed by the administrative,
- 7 professional, technical and clerical employees necessary for the
- 8 operation of the program.
- 9 (b) Statement of policy.--The department shall adopt a
- 10 statement of policy for the maintenance and use of the fund <--
- 11 ACCOUNT within 60 days of the effective date of this subsection. <--
- 12 The policy shall be transmitted as a notice to the Legislative
- 13 Reference Bureau for publication in the Pennsylvania Bulletin
- 14 <u>but shall not be subject to review under section 205 of the act</u>
- 15 of July 31, 1968 (P.L.769, No.240), referred to as the
- 16 Commonwealth Documents Law, sections 204(b) and 301(10) of the
- 17 act of October 15, 1980 (P.L.950, No.164), known as the
- 18 Commonwealth Attorneys Act, or the act of June 25, 1982
- 19 (P.L.633, No.181), known as the Regulatory Review Act.
- 20 § 9807. [Funding.] <u>Keystone State Challenge Academy Fund</u>

- 21 ACCOUNT.
- 22 (a) Establishment. -- The Keystone State Challenge Academy
- 23 <u>Fund ACCOUNT is established as a special fund in the State</u> <--
- 24 Treasury NONLAPSING RESTRICTED RECEIPTS ACCOUNT IN THE GENERAL <--
- 25 FUND.
- 26 (b) Appropriation.--All money deposited into the fund <--
- 27 ACCOUNT and the interest the fund ACCOUNT accrues are
- 28 appropriated to the department on a continuing basis to be used
- 29 for the purposes provided under this chapter. MONEY IN THE <--
- 30 ACCOUNT SHALL NOT LAPSE.

- 1 (c) Use of fund ACCOUNT.--The fund ACCOUNT may only be used <--
- 2 for the purposes provided for under this chapter and no money in
- 3 the fund ACCOUNT may be transferred or diverted to any other <--
- 4 purpose by administrative action.
- 5 (d) Sources of money. -- Money available to the fund ACCOUNT <--
- 6 <u>shall include appropriations and transfers from the General</u>
- 7 Fund, special funds, Federal funds and other sources of revenue
- 8 made available to the fund ACCOUNT.
- 9 <u>(e) Allocation.--Money from the fund ACCOUNT shall be</u> <--

- 10 allocated for the purposes provided for under this chapter no
- 11 <u>later than October 31, 2021, and each October 31 thereafter.</u>
- 12 <u>(f) Funding.--</u>The department shall apply for funding, as
- 13 provided for under 32 U.S.C. § 509(d) (relating to National
- 14 Guard Youth Challenge Program of opportunities for civilian
- 15 youth). Under 32 U.S.C. § 509(j), the department may supplement
- 16 such funding with other resources, including gifts, made
- 17 available to the department and may also accept, use and dispose
- 18 of gifts or donations of money, other property or services for
- 19 the program.
- 20 § 9810. Report.
- 21 [The department shall submit annually to] By September 30,
- 22 <u>2021</u>, and each September 30 thereafter, the department shall
- 23 submit to the chairperson and minority chairperson of the
- 24 Appropriations Committee of the Senate, the chairperson and
- 25 minority chairperson of the Education Committee of the Senate,
- 26 the chairperson and minority chairperson of the Veterans Affairs
- 27 and Emergency Preparedness Committee of the Senate, the
- 28 chairperson and minority chairperson of the Appropriations
- 29 <u>Committee of the House of Representatives</u>, the chairperson and
- 30 minority chairperson of the Education Committee of the House of

- 1 Representatives and the chairperson and minority chairperson of
- 2 the Veterans Affairs and Emergency Preparedness Committee of the
- 3 House of Representatives a written report concerning the
- 4 program. The report shall include, but not be limited to, all of
- 5 the following:
- 6 (1) The number of individuals who applied to the program
- 7 in the previous fiscal year.
- 8 (2) The number of individuals who participated in the
- 9 program in the previous fiscal year.
- 10 (3) The number and percentage of program participants in
- 11 the previous fiscal year who achieved each of the following:
- 12 (i) Earned a high school diploma or its equivalent.
- 13 (ii) Enrolled in a course of study at an institution
- of higher education.
- 15 (iii) Accepted a position of full-time, paid
- 16 employment.
- 17 (iv) Accepted a position of part-time, paid
- 18 employment.
- 19 (v) Entered the armed forces of the United States,
- including a reserve component or the National Guard.
- 21 (4) The demographic makeup of the applicants to, and
- 22 participants in, the program, including, but not limited to,
- 23 the following:
- 24 (i) Race.
- 25 (ii) Age.
- 26 (iii) Gender.
- 27 (4.1) Details on the revenues and expenditures of the
- 28 <u>fund ACCOUNT in the prior fiscal year and the identification</u> <--
- 29 and description of activities, programs and projects which
- 30 received money from the fund ACCOUNT.

- 1 (5) Any information the department provides to the
- 2 Secretary of Defense under 32 U.S.C. § 509(k) (relating to
- 3 National Guard Youth Challenge Program of opportunities for
- 4 civilian youth).
- 5 § 9811. Audit required.
- 6 The department shall undergo an annual audit of the program.
- 7 The audit shall be conducted as part of the Commonwealth's
- 8 <u>Single Audit</u> by a qualified [independent] certified public
- 9 accountant under generally accepted audit standards of the
- 10 Governmental Accounting Standards Board. The audit shall be
- 11 submitted to the following:
- 12 (1) The chairperson and minority chairperson of the
- [Education] <u>Appropriations</u> Committee of the Senate.
- 14 (1.1) The chairperson and minority chairperson of the
- 15 Education Committee of the Senate.
- 16 (2) The chairperson and minority chairperson of the
- 17 Veterans Affairs and Emergency Preparedness Committee of the
- 18 Senate.
- 19 (2.1) The chairperson and minority chairperson of the
- 20 Appropriations Committee of the House of Representatives.
- 21 (3) The chairperson and minority chairperson of the
- 22 Education Committee of the House of Representatives.
- 23 (4) The chairperson and minority chairperson of the
- 24 Veterans Affairs and Emergency Preparedness Committee of the
- 25 House of Representatives.
- 26 Section 3. This act shall take effect immediately.
