1 2 3 4	Amending Title 3 (Agriculture) of the Pennsylvania Consolidated Statutes, in Agriculture Rapid Response Disaster Readiness Account, further providing for eligible disaster funding and for Agriculture Rapid Response Disaster Readiness Account.
5	The General Assembly of the Commonwealth of Pennsylvania
6	hereby enacts as follows:
7	Section 1. Sections 11104 and 11107(a) of Title 3 of the
8	Pennsylvania Consolidated Statutes are amended to read:
9	§ 11104. Eligible disaster funding.
10	Purposes for which money from the account may be used by the
11	department shall include, but are not limited to, the following:
12	(1) To mitigate, contain, control, eradicate, prevent or
13	limit the spread of any of the following if the secretary
14	determines any of the following poses an immediate danger to
15	public or animal health, food safety or economic well-being
16	in this Commonwealth:
17	(i) Transmissible disease.
18	(ii) Hazardous substance contamination.

1	(iii) Plant pests.
2	(iv) Invasive species.
3	(v) Plant diseases.
4	(vi) Noxious weeds.
5	(vii) Controlled plants.
6	(viii) Foodborne illness.
7	(2) To assist in providing transportation of livestock
8	feed from a commercial feed establishment in the event of a
9	disaster declaration issued by the Governor that includes the
10	department.
11	(2.1) To make grants to livestock feed sellers and
12	livestock producers for economic loss as a result of the
13	proclamation of disaster emergency issued by the Governor on
14	March 6, 2020, published at 50 Pa.B. 1644 (March 21, 2020),
15	and any renewal of the state of disaster emergency. The
16	following apply:
17	(i) The grants shall be paid from the restricted
18	account established under section 11107(a)(2) (relating
19	to Agriculture Rapid Response Disaster Readiness
20	<u>Account).</u>
21	(ii) A grant issued under this paragraph shall not
22	<u>exceed \$10,000 in a 12-month period.</u>
23	(3) To make grants for and acquire data regarding any
24	item under paragraph (1). No more than \$100,000 may be used
25	for this purpose in a year.
26	(4) To provide additional financial assistance as may be
27	requested in a declaration of disaster issued by the Governor
28	that includes the department.
29	(5) To provide up to \$250,000 annually to animal
30	response teams recognized and approved by the Pennsylvania

Emergency Management Agency for planning, developing and maintaining animal response and rescue capabilities consistent with standards and guidelines established by the agency in conjunction with the department.

5 § 11107. Agriculture Rapid Response Disaster Readiness Account.
6 (a) Establishment.--

7 The Agriculture Rapid Response Disaster Readiness (1) 8 Account is established as a special nonlapsing account in the 9 State Treasury. All money allocated to or supplements to the 10 account and the interest collected on money and supplements shall be paid into the account. All money placed into the 11 12 account and the interest the account accrues are appropriated 13 to the department on a continuing basis for activities 14 necessary to meet the requirements of this chapter.

15 (2) A restricted account is established in the account to be used for grants under section 11104(2.1) (relating to 16 17 eligible disaster funding). The restricted account shall_ 18 consist of money appropriated or transferred to the 19 restricted account from the Budget Stabilization Reserve 20 Fund. * * * 21 Section 2. This act shall take effect immediately. 22
