A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania, further providing for proposal of amendments
- by the General Assembly and their adoption.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby resolves as follows:
- 6 Section 1. The following amendment to the Constitution of
- 7 Pennsylvania is proposed in accordance with Article XI:
- 8 That section 1 of Article XI be amended to read:
- 9 § 1. Proposal of amendments by the General Assembly and their
- 10 adoption.
- 11 Amendments to this Constitution may be proposed in the Senate
- 12 or House of Representatives; and if the same shall be agreed to
- 13 by a majority of the members elected to each House, such
- 14 proposed amendment or amendments shall be entered on their
- 15 journals with the yeas and nays taken thereon, and the
- 16 [Secretary of the Commonwealth] Secretary of the Senate or the

- 1 Chief Clerk of the House of Representatives, as appropriate,
- 2 LEGISLATIVE REFERENCE BUREAU OR A SUCCESSOR LEGISLATIVE AGENCY
- 3 PRESCRIBED BY THE GENERAL ASSEMBLY shall cause the same to be
- 4 published three months before the next general election, in at
- 5 least two newspapers in every county in which such newspapers
- 6 shall be published; and if, in the General Assembly next
- 7 afterwards chosen, such proposed amendment or amendments shall
- 8 be agreed to by a majority of the members elected to each House,
- 9 the [Secretary of the Commonwealth] Secretary of the Senate or <--
- 10 the Chief Clerk of the House of Representatives, as appropriate, <--
- 11 <u>LEGISLATIVE REFERENCE BUREAU OR A SUCCESSOR LEGISLATIVE AGENCY</u>
- 12 PRESCRIBED BY THE GENERAL ASSEMBLY shall cause the same again to
- 13 be published in the manner aforesaid; and such proposed
- 14 amendment or amendments shall be submitted to the qualified
- 15 electors of the State in such manner, and at such time at least
- 16 three months after being so agreed to by the two Houses, as the
- 17 General Assembly shall prescribe; and, if such amendment or
- 18 amendments shall be approved by a majority of those voting
- 19 thereon, such amendment or amendments shall become a part of the
- 20 Constitution; but no amendment or amendments shall be submitted
- 21 oftener than once in five years. When two or more amendments
- 22 shall be submitted they shall be voted upon separately.
- 23 (a) In the event a major emergency threatens or is about to
- 24 threaten the Commonwealth and if the safety or welfare of the
- 25 Commonwealth requires prompt amendment of this Constitution,
- 26 such amendments to this Constitution may be proposed in the
- 27 Senate or House of Representatives at any regular or special
- 28 session of the General Assembly, and if agreed to by at least
- 29 two-thirds of the members elected to each House, a proposed
- 30 amendment shall be entered on the journal of each House with the

- 1 yeas and nays taken thereon and the [official in charge of
- 2 statewide elections] <u>Secretary of the Senate or the Chief Clerk</u> <--
- 3 <u>of the House of Representatives, as appropriate, LEGISLATIVE</u> <-
- 4 REFERENCE BUREAU OR A SUCCESSOR LEGISLATIVE AGENCY PRESCRIBED BY
- 5 THE GENERAL ASSEMBLY shall promptly publish such proposed
- 6 amendment in at least two newspapers in every county in which
- 7 such newspapers are published. Such amendment shall then be
- 8 submitted to the qualified electors of the Commonwealth in such
- 9 manner, and at such time, at least one month after being agreed
- 10 to by both Houses as the General Assembly prescribes.
- 11 (b) If an emergency amendment is approved by a majority of
- 12 the qualified electors voting thereon, it shall become part of
- 13 this Constitution. When two or more emergency amendments are
- 14 submitted they shall be voted on separately.
- (c) Second publication of a proposed amendment, or
- 16 publication of a proposed emergency amendment, shall include
- 17 only the language of the amendment along with, as prepared by
- 18 the Secretary of the Senate or the Chief Clerk of the House as
- 19 appropriate LEGISLATIVE REFERENCE BUREAU OR A SUCCESSOR
- 20 <u>LEGISLATIVE AGENCY PRESCRIBED BY THE GENERAL ASSEMBLY</u>, both the
- 21 <u>question to be used on the ballot and a summary of the</u>
- 22 <u>amendment</u>.
- 23 Section 2. (a) Upon the first passage by the General
- 24 Assembly of this proposed constitutional amendment, the
- 25 Secretary of the Commonwealth shall proceed immediately to
- 26 comply with the advertising requirements of section 1 of Article
- 27 XI of the Constitution of Pennsylvania and shall transmit the
- 28 required advertisements to two newspapers in every county in
- 29 which such newspapers are published in sufficient time after
- 30 passage of this proposed constitutional amendment. The Secretary

- 1 of the Commonwealth shall issue a report on the publication
- 2 required under this subsection to the Secretary of the Senate
- 3 and the Chief Clerk of the House of Representatives four months
- 4 prior to the next general election.
- 5 (b) Upon the second passage by the General Assembly of this
- 6 proposed constitutional amendment, the Secretary of the
- 7 Commonwealth shall proceed immediately to comply with the
- 8 advertising requirements of section 1 of Article XI of the
- 9 Constitution of Pennsylvania and shall transmit the required
- 10 advertisements to two newspapers in every county in which such
- 11 newspapers are published in sufficient time after passage of
- 12 this proposed constitutional amendment. The Secretary of the
- 13 Commonwealth shall submit this proposed constitutional amendment
- 14 as a single ballot question to the qualified electors of this
- 15 Commonwealth at the first primary, general or municipal election
- 16 which meets the requirements of and is in conformance with
- 17 section 1 of Article XI of the Constitution of Pennsylvania and
- 18 which occurs at least three months after the proposed
- 19 constitutional amendment is passed by the General Assembly. The
- 20 Secretary of the Commonwealth shall issue a report on the
- 21 publication required under this subsection to the Secretary of
- 22 the Senate and the Chief Clerk of the House of Representatives
- 23 four months prior to the first primary, general or municipal
- 24 election which meets the requirements of and is in conformance
- 25 with section 1 of Article XI of the Constitution of Pennsylvania
- 26 and which occurs at least three months after the proposed
- 27 constitutional amendment is passed by the General Assembly.
