- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in liquid fuels and fuels tax, further providing 2 for definitions and providing for electric vehicle road use 3 fee; and making editorial changes. 4 5 The General Assembly of the Commonwealth of Pennsylvania 6 hereby enacts as follows: 7 Section 1. Chapter 90 of Title 75 of the Pennsylvania Consolidated Statutes is amended by adding a subchapter heading 9 to read: 10 SUBCHAPTER A 11 PRELIMINARY PROVISIONS 12 Section 2. Section 9002 of Title 75 is amended by adding definitions to read: 13 § 9002. Definitions. 14 15 The following words and phrases when used in this chapter 16 shall have the meanings given to them in this section unless the context clearly indicates otherwise: 17
- 19 "Electric vehicle." The term includes electric vehicles and

- 1 <u>hybrid electric vehicles. The term does not include qualified</u>
- 2 motor vehicles as defined under section 2101.1 (relating to
- 3 definitions) and neighborhood electric vehicles as defined
- 4 <u>section 102 (relating to definitions).</u>
- 5 <u>"Electric vehicle road use fee." The annual fee imposed</u>
- 6 <u>under Subchapter C (relating to electric vehicle road use fee)</u>
- 7 <u>in place of a tax on alternative fuels assessed upon electricity</u>
- 8 <u>used in electric vehicles.</u>
- 9 "Exempt entity." A person exempt under section 9004(e)
- 10 (relating to imposition of tax, exemptions and deductions) from
- 11 reporting and paying a tax on liquid fuels, fuels or alternative
- 12 <u>fuels imposed by this chapter.</u>

- 21 9031. Short title of subchapter.
- 22 <u>9032</u>. Road use fee imposed on electric vehicles.
- 23 9033. Electricity used in electric vehicles.

- 28 § 9031. Short title of subchapter.
- 29 This subchapter shall be known and may be cited as the
- 30 Electric Vehicle Road Use Fee Act.

- 1 § 9032. Road use fee imposed on electric vehicles.
- 2 (a) Fee required for registration. -- Concurrent with
- 3 <u>submitting an annual or biennial vehicle registration</u>
- 4 application and fee to the Department of Transportation under
- 5 <u>section 1301 (relating to registration and certificate of title</u>
- 6 required), an owner of an electric vehicle shall submit the
- 7 <u>electric vehicle road use fee. The following shall apply:</u>
- 8 (1) Registration may not be considered complete without
- 9 payment in full of the electric vehicle road use fee.
- 10 (2) The electric vehicle road use fee shall be paid upon
- initial registration and upon renewal for each electric
- vehicle registered in this Commonwealth.
- 13 (b) Computation of electric vehicle road use fee.--
- 14 <u>(1) The electric vehicle road use fee for any electric</u>
- motorcycle.
- 16 (2) The electric vehicle road use fee for any hybrid
- 17 electric vehicle with a gross vehicle weight rating of not
- more than 26,000, but not a motorcycle, shall be \$75 per
- 19 year.
- 20 (3) The electric vehicle road use fee for any electric
- 21 <u>vehicle with a gross vehicle weight rating of not more than</u>
- 22 26,000, but not a motorcycle, shall be \$380 per year. For
- 23 purposes of this subparagraph, an electric vehicle shall not
- include a hybrid electric vehicle.
- 25 (4) The electric vehicle road use fee for any electric
- vehicle with a gross vehicle weight rating of 26,001 or more
- shall be \$450 per year.
- 28 § 9033. Electricity used in electric vehicles.
- 29 <u>Electricity used in an electric vehicle that propels a</u>
- 30 vehicle on public highways is not considered a liquid fuel, fuel

- 1 or alternative fuel as defined under this chapter.
- 2 § 9034. Fees for highway maintenance and construction.
- Fees collected under this subchapter shall be deposited in
- 4 the Motor License Fund in accordance with the allocations under
- 5 <u>section 9511 (relating to allocation of proceeds). For purposes</u>
- 6 of aligning the electric vehicle road use fee with the
- 7 <u>allocations of proceeds, the electric vehicle road use fee must</u>
- 8 be allocated in accordance with the oil company franchise tax
- 9 for highway maintenance and construction under section 9502
- 10 (relating to imposition of tax).
- 11 § 9035. Exempt entities.
- 12 (a) Exemption. -- An electric vehicle registered to an exempt
- 13 entity under section 9004(e) (relating to imposition of tax,
- 14 <u>exemptions and deductions</u>) is exempt from paying the electric
- 15 vehicle road use fee.
- 16 (b) Requirements. -- The following apply:
- 17 (1) If an electric vehicle registered to an exempt
- 18 entity is used for a nonexempt purpose during the
- 19 registration year, the exempt entity shall pay an
- 20 administrative penalty of \$500 to the department. An exempt
- 21 entity that improperly uses a vehicle for nonexempt purposes
- is not eligible to claim a refund for the vehicle under the
- 23 provisions of section 9036 (relating to refunds).
- 24 (2) An exempt entity applying for a refund under section
- 25 9036 shall maintain records of vehicle usage, certifying that
- an individual trip made by the vehicle was for a qualified
- 27 <u>exempt use. Individual trip logs, odometer readings and</u>
- driver signatures shall be among the records required to
- 29 substantiate exempt use.
- 30 (3) The department may inspect the substantiating

- 1 records for an exempt entity at any time.
- 2 (4) The exempt entity shall cooperate with an agent of
- 3 <u>the department in an inspection.</u>
- 4 (5) An exempt entity that refuses to permit the
- 5 <u>department or an agent appointed by the department in writing</u>
- to examine the books, records, papers or other equipment
- 7 <u>associated with the operation of an electric vehicle commits</u>
- 8 <u>a summary offense and shall pay a fine of \$500 for each</u>
- 9 electric vehicle owned or operated by the exempt entity.
- 10 § 9036. Refunds.
- 11 A person may be entitled to a refund of the electric vehicle
- 12 road use fee paid for a vehicle that would otherwise have been
- 13 exempt under section 9004 (relating to imposition of tax,
- 14 exemptions and deductions). A person entitled to a refund of the
- 15 <u>electric vehicle road use fee shall apply for an annual refund</u>
- 16 <u>in a manner similar to the refund process used for liquid fuels</u>,
- 17 fuels and alternative fuels under section 9017 (relating to
- 18 refunds).
- 19 § 9037. Regulations.
- The department, in coordination with the Department of
- 21 Transportation, may promulgate regulations to implement the
- 22 addition of this subchapter.
- 23 Section 4. This act shall take effect in 180 days.
