17	§ 1541. Definitions.
18	The following words and phrases when used in this subchapter
1 0	shall have the meanings given to them in this section unless the

- 1 context clearly indicates otherwise:
- 2 "Charter school." A charter school, a regional charter
- 3 school or a cyber charter school.
- 4 "Chief school administrator." The superintendent of a school
- 5 district, superintendent of an area vocational-technical school,
- 6 <u>executive director of an intermediate unit or chief executive</u>
- 7 <u>officer of any charter school.</u>
- 8 <u>"Facilities."</u> Facilities of a public utility engaged in the
- 9 transmission of hazardous liquids by pipeline or conduit, any
- 10 part of which is located within 1,000 feet of a school building.
- 11 "Hazardous liquid." As defined in 49 CFR 195.2 (relating to
- 12 definitions).
- 13 "Nonpublic school." A nonprofit school, other than a school
- 14 entity, wherein a resident of this Commonwealth may legally
- 15 <u>fulfill the compulsory school attendance requirements of Article</u>
- 16 XIII of the act of March 10, 1949 (P.L.30, No.14), known as the
- 17 Public School Code of 1949, and which meets the requirements of
- 18 Title VI of the Civil Rights Act of 1964 (Public Law 88-352, 78
- 19 Stat. 241).
- 20 "Operator." An operator or owner of facilities.
- 21 "School." A school operated by a school entity or nonpublic
- 22 school.
- 23 "School building." A building owned by or under the control
- 24 of a school entity or nonpublic school where classes are taught
- 25 or extracurricular activities are conducted on a regular basis.
- 26 The term includes the following:
- 27 (1) A cyber charter school building where cyber charter
- 28 <u>school students congregate for classes.</u>
- 29 (2) The grounds adjacent to a building or facility where
- 30 students congregate as part of the school day or a school-

- 1 sponsored activity, including school playgrounds.
- 2 <u>"School entity." A school district, charter school, regional</u>
- 3 charter school, cyber charter school, intermediate unit or area
- 4 <u>vocational-technical school.</u>
- 5 "Transmission." The transportation, other than gathering, of
- 6 <u>hazardous liquids through a pipeline as that term is defined in</u>
- 7 49 CFR 195.2 (relating to definitions).
- 8 § 1542. Information regarding transmission of hazardous liquids
- 9 <u>near school buildings.</u>
- 10 (a) General rule. -- Within six months of the completion of
- 11 construction of facilities and no later than January 15 of every
- 12 odd-numbered year thereafter, an operator shall file with the
- 13 commission the following information:
- 14 (1) The name of each school located within 1,000 feet of
- 15 the facilities.
- 16 (2) The street address of each school building located
- within 1,000 feet of the facilities.
- 18 (3) The identification (system name) of the facilities.
- 19 (b) Emergency response plan. -- An operator shall:
- 20 (1) Upon written request from the governing board of a
- 21 <u>school entity or a nonpublic school, provide in writing the</u>
- following parts of a pipeline emergency response plan that
- are relevant to a school building:
- (i) A description and map of the facilities that are
- 25 <u>located within 1,000 feet of the school building.</u>
- 26 (ii) A list of any product transported in the
- 27 <u>segment of the facilities that are located within 1,000</u>
- feet of the school building.
- 29 (iii) The designated emergency number for the
- 30 operator.

- 1 (iv) Information on the Commonwealth's excavation
- 2 <u>One Call System.</u>
- 3 (v) Information on how to recognize, report and
- 4 <u>respond to a product release.</u>
- 5 (2) Mail a copy of the information requested under
- 6 paragraph (1) by certified mail, return receipt requested, to
- 7 the chief school administrator of the school entity or the
- 8 <u>director of the nonpublic school.</u>
- 9 (c) Meetings.--If requested by the governing board of the
- 10 school entity or nonpublic school, an operator or the operator's
- 11 representative shall appear at a regularly scheduled meeting of
- 12 the governing board of a school entity or nonpublic school to
- 13 explain the items listed under subsections (a) and (b) if
- 14 requested by the governing board of the school entity or
- 15 <u>nonpublic school.</u>
- 16 <u>§ 1543. Record requirement.</u>
- 17 (a) General rule. -- An operator shall maintain records
- 18 documenting compliance with the requirements of this subchapter.
- 19 (b) Maintenance of records. -- Records of attendance and
- 20 acknowledgment of receipt of the requested information by the
- 21 chief school administrator of a school entity or the director of
- 22 a nonpublic school shall be retained for five years from the
- 23 date of the event that is commemorated by the record.
- 24 (c) Certified mail records. -- Records of certified mail
- 25 transmissions undertaken in compliance with this subsection
- 26 shall satisfy the record-keeping requirements of this section.
- 27 Section 2. This act shall take effect in 60 days.
