AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, in registration of vehicles, providing for Blue
- 3 Star Family plate.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 75 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 <u>§ 1366.2. Blue Star Family plate.</u>
- 9 <u>(a) General rule.--Upon application of a family member of a</u>
- 10 person who is an active duty service member in the military,
- 11 accompanied by a fee of \$20 which shall be in addition to the
- 12 <u>annual registration fee and by such documentation as the</u>
- 13 <u>department shall require</u>, the department shall issue to the
- 14 <u>family member a special registration plate designating the</u>
- 15 <u>vehicle so licensed as belonging to a family member of a person</u>
- 16 <u>serving on active duty in the military. The department shall</u>
- 17 <u>design and produce the special registration plate carrying the</u>

- 1 Blue Star which signifies that a family member is an active duty
- 2 <u>service member. The words "Blue Star Family" shall be clearly</u>
- 3 <u>displayed along the bottom of the plate. The special</u>
- 4 <u>registration plate may be used only on a passenger car or truck</u>
- 5 with a registered gross weight of not more than 14,000 pounds.
- 6 (b) Documentation required. -- An applicant for a Blue Star
- 7 Family plate shall certify on a form approved by the department
- 8 that the applicant is a family member of a person who is an
- 9 <u>active duty service member in the military.</u>
- 10 (c) Definition. -- As used in this section, the term "family
- 11 member" includes the following:
- 12 <u>(1) Mother.</u>
- 13 <u>(2) Father.</u>
- 14 <u>(3) Stepmother.</u>
- 15 (4) Stepfather.
- 16 (5) Mother through adoption.
- 17 (6) Father through adoption.
- 18 (7) Foster mother in loco parentis.
- 19 (8) Foster father in loco parentis.
- 20 (9) Son.
- 21 (10) Daughter.
- 22 <u>(11) Stepson.</u>
- 23 <u>(12) Stepdaughter.</u>
- 24 (13) Son by adoption.
- 25 (14) Daughter by adoption.
- 26 (15) Brother.
- 27 <u>(16) Sister.</u>
- 28 (17) Half-brother.
- 29 (18) Half-sister.
- 30 <u>(19) Grandfather.</u>

- 1 (20) Grandmother.
- 2 Section 2. This act shall take effect in 60 days.
