## AN ACT

- Amending the act of June 3, 1937 (P.L.1333, No.320), entitled 1 "An act concerning elections, including general, municipal, 2 special and primary elections, the nomination of candidates, 3 primary and election expenses and election contests; creating 4 and defining membership of county boards of elections; 5 imposing duties upon the Secretary of the Commonwealth, 6 courts, county boards of elections, county commissioners; 7 imposing penalties for violation of the act, and codifying, 8 revising and consolidating the laws relating thereto; and 9 repealing certain acts and parts of acts relating to 10 elections," in voting by qualified absentee electors, further 11 providing for canvassing of official absentee ballots and 12 mail-in ballots. 13 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1. Section 1308(q)(3) of the act of June 3, 1937(P.L.1333, No.320), known as the Pennsylvania Election Code, 17 18 amended March 27, 2020 (P.L.41, No.12), is amended to read: 19 Section 1308. Canvassing of Official Absentee Ballots and 20 Mail-in Ballots.--\* \* \* 21 (q)
- 22 (3) When the county board meets to pre-canvass or canvass

- 1 absentee ballots and mail-in ballots under paragraphs (1), (1.1)
- 2 and (2), the board shall examine the declaration on the envelope
- 3 of each ballot not set aside under subsection (d) and shall
- 4 compare the information thereon with that contained in the
- 5 "Registered Absentee and Mail-in Voters File," the absentee
- 6 voters' list and/or the "Military Veterans and Emergency
- 7 Civilians Absentee Voters File, "whichever is applicable. The
- 8 <u>examination shall include a comparison of the elector's</u>
- 9 signature of record against the signature on the declaration of
- 10 the elector. If the board finds that the two signatures do not
- 11 match, the ballot shall be set aside and declared void. If the
- 12 county board has verified the proof of identification as
- 13 required under this act and is satisfied that the declaration is
- 14 sufficient and the information contained in the "Registered
- 15 Absentee and Mail-in Voters File," the absentee voters' list
- 16 and/or the "Military Veterans and Emergency Civilians Absentee
- 17 Voters File" verifies his right to vote, the county board shall
- 18 provide a list of the names of electors whose absentee ballots
- 19 or mail-in ballots are to be pre-canvassed or canvassed.

- 21 Section 2. This act shall take effect in 60 days.
