## AN ACT

- Amending the act of August 26, 1971 (P.L.351, No.91), entitled
  "An act providing for a State Lottery and administration
  thereof; authorizing the creation of a State Lottery
  Commission; prescribing its powers and duties; disposition of
  funds; violations and penalties therefor; exemption of prizes
  from State and local taxation and making an appropriation,"
  in State lottery, further providing for statement of purpose,
  for powers and duties of secretary and for disposition of
  funds and providing for instant lottery game to benefit
  veterans.
- 11 The General Assembly of the Commonwealth of Pennsylvania
- 12 hereby enacts as follows:
- 13 Section 1. Sections 301, 303(a)(11) and 311 of the act of
- 14 August 26, 1971 (P.L.351, No.91), known as the State Lottery
- 15 Law, are amended to read:
- 16 Section 301. Statement of purpose.
- 17 This chapter is enacted to establish a lottery to be operated
- 18 by the State, the net proceeds of which are to be used after
- 19 June 30, 1972, for the purposes of providing property tax relief
- 20 for the elderly for taxes paid in 1971 and thereafter to persons
- 21 65 years of age or older and for providing certain free fixed

- 1 route local transit services to persons 65 years of age or older
- 2 and reduced fare on group ride transit service to persons 65
- 3 years of age or older and for establishing an instant lottery
- 4 game to benefit veterans. It is further intended to provide a
- 5 means through which to curb illegal gambling operations in
- 6 Pennsylvania.
- 7 Section 303. Powers and duties of secretary.
- 8 (a) Powers and duties enumerated. -- In addition to the powers
- 9 and duties provided by law and the act of April 9, 1929
- 10 (P.L.177, No.175), known as The Administrative Code of 1929, the
- 11 secretary shall have the power and it shall be his duty to
- 12 operate and administer the lottery, and to promulgate rules and
- 13 regulations governing the establishment and operation thereof,
- 14 including, but not limited to:

- 16 (11) The apportionment of the total revenues accruing
  17 from the sale of lottery tickets or shares and from all other
  18 sources among:
- 19 (i) [the] <u>The</u> payment of prizes to the holders of winning tickets or shares[;].
  - (ii) [the] The payment of costs incurred in the operation and administration of the lottery, including the expenses of the division and the costs resulting from any contract or contracts entered into for promotional, advertising or operational services or for the purchase or lease of lottery equipment and materials[; and].
  - (iv) [for] For property tax relief and free or reduced fare transit service for the elderly as provided in section 311. For fiscal years beginning before July 1, 2014, no less than 27% of the total revenues accruing

1 from the sale of lottery tickets or shares shall be 2 dedicated to this subparagraph. For fiscal years 3 beginning after June 30, 2014, and ending June 30, 2019, no less than 25% of the total revenues accruing from the 4 sale of lottery tickets or shares shall be dedicated to 5 6 this subparagraph. For fiscal years beginning after June 7 30, 2019, and ending June 30, 2024, no less than 20% of 8 the total revenues accruing from the sale of lottery tickets or shares shall be dedicated to this 9 10 subparagraph. For fiscal years beginning after June 30, 11 2024, no less than 25% of the total revenues accruing 12 from the sale of lottery tickets or shares shall be 13 dedicated to this subparagraph.

(v) The payment to the Veterans' Trust Fund for veterans services, outreach and benefit programs as provided in section 316. All proceeds accruing from the sale of instant lottery games under section 316, after the payment of prizes and operational and administrative costs, shall be dedicated to this subparagraph.

- 21 Section 311. Disposition of funds.
- 22 State Lottery Fund. -- All moneys received from the 23 operation of the State lottery shall be deposited in a State 24 Lottery Fund which is hereby created. Such moneys shall be used 25 to the extent necessary for the payment of lottery prizes but the amount so used shall not be less than 40% of the amount of 26 which tickets or shares have been sold. All payments of lottery 27 28 prizes and for expenses of operation of the lottery shall be made as provided by law. All moneys remaining after payment of 29

prizes and operating expenses shall remain in the State Lottery

- 1 Fund and shall be allocated for the purpose of providing
- 2 property tax relief for the elderly for taxes paid in 1971 and
- 3 thereafter pursuant to [the provisions of the act of March 11,
- 4 1971 (P.L.104, No.3), known as the Senior Citizens Rebate and
- 5 Assistance Act] Chapter 13 of the act of June 27, 2006 (1st\_
- 6 Sp.Sess., P.L.1873, No.1), known as the Taxpayer Relief Act, and
- 7 for the purpose of providing free or reduced fare transit
- 8 service for the elderly pursuant to Chapter 9 and the act of
- 9 February 11, 1976 (P.L.14, No.10), known as the Pennsylvania
- 10 Rural and Intercity Common Carrier Surface Transportation
- 11 Assistance Act and for veterans services, outreach and benefit
- 12 programs as provided in section 316. In the event sufficient
- 13 funds are not available from the lottery receipts to meet the
- 14 requirements of [the Senior Citizens Rebate and Assistance Act]
- 15 <u>Chapter 13 of the Taxpayer Relief Act</u> or for providing free or
- 16 reduced fare transit service for the elderly under Chapter 9 and
- 17 the Pennsylvania Rural and Intercity Common Carrier Surface
- 18 Transportation Assistance Act or for veterans services, outreach
- 19 and benefit programs as provided in section 316, additional
- 20 funds to fulfill these obligations shall be appropriated from
- 21 the General Fund for this purpose.
- 22 (b) Appropriations. -- The moneys in said State Lottery Fund
- 23 shall be appropriated only:
- 24 (1) For the payment of prizes to the holders of winning
- 25 lottery tickets or shares.
- 26 (2) For the expenses of the division in its operation of
- 27 the lottery.
- 28 (3) For property tax relief and free or reduced fare
- transit service for the elderly as provided under subsection
- 30 (a).

- 1 (4) To the Veterans' Trust Fund for veterans services,
- 2 <u>outreach and benefit programs as provided in section 316.</u>
- 3 Section 2. The act is amended by adding a section to read:
- 4 <u>Section 316. Instant lottery game to benefit veterans.</u>
- 5 (a) General rule. -- The secretary shall operate an instant
- 6 lottery game to benefit veterans of the armed forces of the
- 7 <u>United States who reside in this Commonwealth. The game tickets</u>
- 8 <u>must clearly state that the game proceeds are used to benefit</u>
- 9 <u>veterans in this Commonwealth.</u>
- 10 (b) Advertisement.--
- 11 (1) The secretary shall market and advertise the instant
- 12 <u>lottery game operated under this section to inform the public</u>
- 13 <u>that the game tickets are available for purchase daily and</u>
- that the game proceeds will be used to fund the following:
- (i) Veterans' day-care services as established and
- administered by the Department of Military and Veterans
- 17 Affairs.
- 18 (ii) Veterans' benefit programs as provided by the
- 19 Commonwealth.
- 20 (iii) Veterans' outreach as determined by the
- 21 <u>Department of Military and Veterans Affairs.</u>
- 22 (2) The secretary shall change the design or theme of
- 23 the game regularly to ensure that the game remains
- 24 competitive with all instant lottery games offered by the
- 25 State lottery.
- 26 (c) Transfer of funds. -- On April 30 of each year, the
- 27 <u>secretary shall transfer all proceeds from the sale of the</u>
- 28 instant lottery game tickets as provided under section 303(a)
- 29 (11) (v) to the Veterans' Trust Fund for purposes specified in 51
- 30 Pa.C.S. § 1721(c) (relating to Veterans' Trust Fund).

1 Section 3. This act shall take effect in 180 days.
