## AN ACT

- Amending Title 18 (Crimes and Offenses) of the Pennsylvania
  Consolidated Statutes, in offenses against public order and
  decency, further providing for the offense of transporting
  animals in cruel manner.

  The General Assembly of the Commonwealth of Pennsylvania
  hereby enacts as follows:

  Section 1. Section 5538 of Title 18 of the Pennsylvania
- 9 § 5538. Transporting animals in cruel manner.

Consolidated Statutes is amended to read:

- 10 (a) Offense defined. -- A person commits a summary offense if
- 11 the person [carries,] does any of the following:
- 12 <u>(1) Carries,</u> or causes or allows to be carried, in or
- 13 upon any cart or other vehicle whatsoever an animal in a
- 14 cruel or inhumane manner.
- 15 (2) For the purpose of a performance, transports a
- performance animal in a mobile or traveling housing facility
- for the purpose of participation in a traveling animal act.

- 1 (a.1) Custody.--The person taking the offender into custody
- 2 may take charge of the animal and of the vehicle and the
- 3 vehicle's contents, and deposit the same in a safe place of
- 4 custody, and the necessary expenses that may be incurred for
- 5 taking charge of and keeping the same, and sustaining the
- 6 animal, shall be a lien thereon, to be paid before the same can
- 7 lawfully be recovered, or the expenses or any part thereof
- 8 remaining unpaid may be recovered by the person incurring the
- 9 same from the owner of the animal in an action therefor.
- 10 (b) Exception. -- For the purposes of this section, it shall
- 11 not be deemed cruel or inhumane to transport live poultry in
- 12 crates so long as not more than 15 pounds of live poultry are
- 13 allocated to each cubic foot of space in the crate.
- (c) Definitions.--As used in this section, the following
- 15 words and phrases shall have the meanings given to them in this
- 16 subsection unless the context clearly indicates otherwise:
- 17 <u>"Mobile or traveling housing facility." A transporting</u>
- 18 vehicle such as a truck, trailer or railway car, used to
- 19 transport or house a performance animal while traveling for a
- 20 performance.
- 21 "Performance." An exhibition, public showing, presentation,
- 22 display, exposition, fair, animal act, circus, ride, trade show,
- 23 petting zoo, carnival, parade, race or other similar event in
- 24 which a performance animal is required to perform tricks, give
- 25 rides or participate as accompaniments for entertainment,
- 26 amusement or the benefit of a live audience. The term does not
- 27 <u>include a performance that takes place at a nonmobile, permanent</u>
- 28 <u>institution or other fixed facility if the performance animal is</u>
- 29 <u>not transported to the location for the purpose of a</u>
- 30 performance.

- 1 <u>"Performance animal."</u> Any of the following:
- 2 <u>(1) Bear.</u>
- 3 (2) Cheetah.
- 4 <u>(3) Clouded leopard.</u>
- 5 <u>(4) Cougar.</u>
- 6 <u>(5) Elephant.</u>
- 7 <u>(6) Giraffe.</u>
- 8 <u>(7) Grey or red kangaroo.</u>
- 9 <u>(8) Hippopotamus.</u>
- 10 <u>(9) Jaguar.</u>
- 11 <u>(10)</u> <u>Leopard.</u>
- 12 <u>(11) Lion.</u>
- 13 <u>(12) Nonhuman primate.</u>
- 14 <u>(13) Rhinoceros.</u>
- 15 <u>(14) Sea lion.</u>
- 16 <u>(15) Seal.</u>
- 17 <u>(16) Shark.</u>
- 18 <u>(17) Tapir.</u>
- 19 (18) Tiger.
- 20 (19) Zebra.
- 21 "Traveling animal act." A performance of a performance
- 22 animal for which an animal is transported to, from or between
- 23 locations for the purpose of a performance in a mobile or
- 24 traveling animal housing facility.
- 25 Section 2. This act shall take effect in 60 days.
