A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania, further providing for tenure of justices,
- judges and justices of the peace.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby resolves as follows:
- 6 Section 1. The following amendment to the Constitution of
- 7 Pennsylvania is proposed in accordance with Article XI:
- 8 That section 15 of Article V be amended to read:
- 9 § 15. Tenure of justices, judges and justices of the peace.
- 10 (a) The regular term of office of justices and judges shall
- 11 be ten years and the regular term of office for judges of the
- 12 municipal court in the City of Philadelphia and of justices of
- 13 the peace shall be six years. The tenure of any justice or judge
- 14 shall not be affected by changes in judicial districts or by
- 15 reduction in the number of judges.
- 16 (b) [A] Except as provided under this section 15(c), a
- 17 justice or judge elected under section 13(a), appointed under

- 1 section 13(d) or retained under this section 15(b) may file a
- 2 declaration of candidacy for retention election with the officer
- 3 of the Commonwealth who under law shall have supervision over
- 4 elections on or before the first Monday of January of the year
- 5 preceding the year in which his term of office expires. If no
- 6 declaration is filed, a vacancy shall exist upon the expiration
- 7 of the term of office of such justice or judge, to be filled by
- 8 election under section 13(a) or by appointment under section
- 9 13(d) if applicable. If a justice or judge files a declaration,
- 10 his name shall be submitted to the electors without party
- 11 designation, on a separate judicial ballot or in a separate
- 12 column on voting machines, at the municipal election immediately
- 13 preceding the expiration of the term of office of the justice or
- 14 judge, to determine only the question whether he shall be
- 15 retained in office. If a majority is against retention, a
- 16 vacancy shall exist upon the expiration of his term of office,
- 17 to be filled by appointment under section 13(b) or under section
- 18 13(d) if applicable. If a majority favors retention, the justice
- 19 or judge shall serve for the regular term of office provided
- 20 herein, unless sooner removed or retired. At the expiration of
- 21 each term a justice or judge shall be eligible for retention as
- 22 provided herein, subject only to the retirement provisions of
- 23 this article.
- 24 (c) A justice of the Supreme Court, JUDGE OF THE SUPERIOR

- 25 COURT OR JUDGE OF THE COMMONWEALTH COURT shall be eligible to
- 26 serve two terms ON EACH COURT. A justice of the Supreme Court,
- 27 JUDGE OF THE SUPERIOR COURT OR JUDGE OF THE COMMONWEALTH COURT
- 28 who shall have exceeded the term limitation prescribed under
- 29 this subsection shall be permitted to complete their current
- 30 <u>term in office.</u>

- 1 Section 2. (a) Upon the first passage by the General
- 2 Assembly of this proposed constitutional amendment, the
- 3 Secretary of the Commonwealth shall proceed immediately to
- 4 comply with the advertising requirements of section 1 of Article
- 5 XI of the Constitution of Pennsylvania and shall transmit the
- 6 required advertisements to two newspapers in every county in
- 7 which such newspapers are published in sufficient time after
- 8 passage of this proposed constitutional amendment.
- 9 (b) Upon the second passage by the General Assembly of this
- 10 proposed constitutional amendment, the Secretary of the
- 11 Commonwealth shall proceed immediately to comply with the
- 12 advertising requirements of section 1 of Article XI of the
- 13 Constitution of Pennsylvania and shall transmit the required
- 14 advertisements to two newspapers in every county in which such
- 15 newspapers are published in sufficient time after passage of
- 16 this proposed constitutional amendment. The Secretary of the
- 17 Commonwealth shall submit this proposed constitutional amendment
- 18 as a single ballot question to the qualified electors of this
- 19 Commonwealth at the first primary, general or municipal election
- 20 which meets the requirements of and is in conformance with
- 21 section 1 of Article XI of the Constitution of Pennsylvania and
- 22 which occurs at least three months after the proposed
- 23 constitutional amendment is passed by the General Assembly.
