A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania, in the judiciary, further providing for
- judicial administration.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby resolves as follows:
- 6 Section 1. The following amendment to the Constitution of
- 7 Pennsylvania is proposed in accordance with Article XI:
- 8 That section 10(c) of Article V be amended to read:
- 9 \\$ 10. Judicial administration.

- 11 (c) [The] Except as provided by law, the Supreme Court shall
- 12 have the power to prescribe general rules governing practice,
- 13 procedure and the conduct of all courts, justices of the peace
- 14 and all officers serving process or enforcing orders, judgments
- 15 or decrees of any court or justice of the peace, including the
- 16 power to provide for assignment and reassignment of classes of
- 17 actions or classes of appeals among the several courts as the
- 18 needs of justice shall require, and for admission to the bar and

- 1 to practice law, and the administration of all courts and
- 2 supervision of all officers of the Judicial Branch, if such
- 3 rules are consistent with this Constitution and neither abridge,
- 4 enlarge nor modify the substantive rights of any litigant, nor
- 5 affect the right of the General Assembly to determine the
- 6 jurisdiction of any court or justice of the peace, nor suspend
- 7 nor alter any statute of limitation or repose. [All laws shall
- 8 be suspended to the extent that they are inconsistent with rules
- 9 prescribed under these provisions. Notwithstanding the
- 10 provisions of this section, the] The General Assembly may by
- 11 statute provide for the manner of testimony of child victims or
- 12 child material witnesses in criminal proceedings, including the
- 13 use of videotaped depositions or testimony by closed-circuit
- 14 television.

- 16 Section 2. (a) Upon the first passage by the General
- 17 Assembly of this proposed constitutional amendment, the
- 18 Secretary of the Commonwealth shall proceed immediately to
- 19 comply with the advertising requirements of section 1 of Article
- 20 XI of the Constitution of Pennsylvania and shall transmit the
- 21 required advertisements to two newspapers in every county in
- 22 which such newspapers are published in sufficient time after
- 23 passage of this proposed constitutional amendment.
- 24 (b) Upon the second passage by the General Assembly of this
- 25 proposed constitutional amendment, the Secretary of the
- 26 Commonwealth shall proceed immediately to comply with the
- 27 advertising requirements of section 1 of Article XI of the
- 28 Constitution of Pennsylvania and shall transmit the required
- 29 advertisements to two newspapers in every county in which such
- 30 newspapers are published in sufficient time after passage of

- 1 this proposed constitutional amendment. The Secretary of the
- 2 Commonwealth shall submit this proposed constitutional amendment
- 3 to the qualified electors of this Commonwealth at the first
- 4 primary, general or municipal election which meets the
- 5 requirements of and is in conformance with section 1 of Article
- 6 XI of the Constitution of Pennsylvania and which occurs at least
- 7 three months after the proposed constitutional amendment is
- 8 passed by the General Assembly.
