## AN ACT

Amending the act of July 19, 1979 (P.L.130, No.48), entitled "An 1 act relating to health care; prescribing the powers and 2 duties of the Department of Health; establishing and 3 providing the powers and duties of the State Health Coordinating Council, health systems agencies and Health Care 5 Policy Board in the Department of Health, and State Health Facility Hearing Board in the Department of Justice; 7 providing for certification of need of health care providers and prescribing penalties," in licensing of health care 8 facilities, further providing for licensure. 10 The General Assembly of the Commonwealth of Pennsylvania 11 12 hereby enacts as follows: 13 Section 1. Section 806(d) of the act of July 19, 1979 14 (P.L.130, No.48), known as the Health Care Facilities Act, is 15 amended to read: Section 806. Licensure. 16 \* \* \* 17 18 (d) Home health care agency regulations. --19 (1) In developing rules and regulations for licensure of 20 home health care agencies the department shall take into consideration the standards of national accreditation 2.1

- 3 practitioners and physician assistants as provided under
- 4 sections 1814(a) and 1835(a) of the Social Security Act (49

- 6 <u>practitioner's or physician assistant's collaborating or</u>
- 7 <u>supervising physician is identified in the patient's written</u>
- 8 plan of treatment.
- 9 (3) Within 30 days of issuance, an order of home health
- 10 care services must be signed and dated by a physician, nurse
- 11 <u>practitioner or physician assistant.</u>
- 12 <u>(4) The supervision of home health aides shall follow</u>
- 13 <u>Federal regulation under 42 CFR 484.80(h) (relating to</u>
- condition of participation: home health aide services).
- 15 (5) Home health care agencies certified as providers by
- the department to the Federal Government for purposes of the
- 17 Medicare program shall be deemed to comply with and satisfy
- 18 the department's regulations governing home health care
- 19 agencies.
