AN ACT

- 1 Amending the act of November 26, 1978 (P.L.1375, No.325),
- entitled "An act providing for the regulation and safety of
- dams and reservoirs, water obstructions and encroachments;
- 4 consolidating and clarifying the programs of the Department
- of Environmental Resources and Navigation Commission for the
- 6 Delaware River; establishing penalties and repealing certain
- acts," further providing for permit issuance and conditions.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Section 9 of the act of November 26, 1978
- 11 (P.L.1375, No.325), known as the Dam Safety and Encroachments
- 12 Act, is amended to read:
- 13 Section 9. Permit issuance and conditions.
- 14 (a) The department shall have the power to grant a permit if
- 15 it determines that the proposed project complies with the
- 16 provisions of this act and the regulations adopted hereunder,
- 17 and complies with all other applicable laws administered by the
- 18 department[, the Pennsylvania Fish Commission] and any river
- 19 basin commission created by interstate compact.

- 1 (b) The department may impose such permit terms and
- 2 conditions regarding construction, operation, maintenance,
- 3 inspection and monitoring of the project as are necessary to
- 4 assure compliance with this act and other laws administered by
- 5 the department[, the Pennsylvania Fish Commission] and any river
- 6 basin commission created by interstate compact.
- 7 (c) Notwithstanding any other provision of law:
- 8 (1) The Pennsylvania Fish and Boat Commission shall have
- 9 <u>no authority or jurisdiction related to stream maintenance or</u>
- 10 clearing activities within this Commonwealth.
- 11 (2) No approval or authorization from the Pennsylvania
- 12 <u>Fish and Boat Commission shall be required for any stream</u>
- 13 <u>maintenance or clearing activities conducted within this</u>
- 14 <u>Commonwealth.</u>
- 15 (3) The department may not delegate its authority
- 16 related to stream maintenance or clearing activities to the
- 17 Pennsylvania Fish and Boat Commission.
- 18 Section 2. This act shall take effect in 60 days.
