AN ACT

1 Designating a bridge, identified as Bridge Key 12099, carrying
 2 Pennsylvania Route 120, also known as Renovo Road, over Young
 3 Women's Creek in Chapman Township, Clinton County, as the
 4 John F. Curcio Memorial Bridge.

5 The General Assembly of the Commonwealth of Pennsylvania
 6 hereby enacts as follows:

7 Section 1. John F. Curcio Memorial Bridge.

8 (a) Findings.--The General Assembly finds and declares as
 9 follows:

10 (1) John F. Curcio was born May 23, 1925, in Brooklyn,
 11 New York, to the late Anthony and Stella (Pagnotto) Curcio.

12 (2) Mr. Curcio worked for the Pennsylvania Railroad,
 13 Penn Central and Conrail from 1947 to 1984.

14 (3) Mr. Curcio served in the 8th United States Army Air
 15 Forces 458th Bomber Group during World War II as a staff
 16 sergeant, completing 35 combat missions, including the Battle
 17 of the Bulge and the invasion at Normandy.

18 (4) For his service, Mr. Curcio was awarded the French

1 Legion of Honor Medal and the Air Medal with four oak leaf
2 clusters.

3 (5) Mr. Curcio was a member of St. Joseph Catholic
4 Church and a graduate of St. Joseph High School.

5 (6) In his spare time, Mr. Curcio enjoyed hunting and
6 fishing and was instrumental in placing flags on the Renovo
7 Bridge.

8 (7) Mr. Curcio's other memberships included the Sons of
9 Italy, Veterans of Foreign Wars 40/8, the American Legion
10 where he served as a past commander and the Elks Lodge as a
11 past Exalted Ruler, all of Renovo.

12 (8) Mr. Curcio is survived by two sisters, Rosemary
13 Andrus of Lock Haven and Ellen Smith of Ashburn, Virginia,
14 and a host of nieces and nephews.

15 (b) Designation.--The bridge, identified as Bridge Key
16 12099, carrying Pennsylvania Route 120, also known as Renovo
17 Road, over Young Women's Creek in Chapman Township, Clinton
18 County, is designated the John F. Curcio Memorial Bridge.

19 (c) Signs.--The Department of Transportation shall erect and
20 maintain appropriate signs displaying the name of the bridge to
21 traffic in both directions on the bridge.

22 Section 2. Effective date.

23 This act shall take effect in 60 days.
