AN ACT

- Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the 4 laws relating thereto," in pupils and attendance, providing for possession of cell phones. 5 6 7 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:
- Section 1. The act of March 10, 1949 (P.L.30, No.14), known 9
- as the Public School Code of 1949, is amended by adding a 10
- 11 section to read:
- 12 Section 1317.4. Possession of Cell Phones. -- (a) Except as
- 13 provided in subsection (b), a student of a public school entity
- may not possess or use a cell phone during the school day in a 14
- school building of the public school entity. The following 15
- 16 apply:
- 17 (1) Upon entering the school building at the beginning of
- 18 the school day, the student shall:
- 19 (i) deposit the cell phone in a lockbox or other secure
- location for the duration of the school day; or 20

- 1 (ii) secure the cell phone in a case or pouch with a locking
- 2 mechanism, if the locking mechanism prohibits the student from
- 3 accessing the cell phone during the school day, so that the
- 4 student may carry the cell phone during the school day.
- 5 (2) At the end of the school day, the student may:
- 6 (i) retrieve the cell phone from the lockbox or other secure
- 7 <u>location; or</u>
- 8 (ii) unlock the case or pouch with the locking mechanism.
- 9 (b) Subsection (a) shall not apply to a student if each of
- 10 the following apply:
- 11 (1) The student:
- 12 (i) is a member of a volunteer fire company, ambulance or
- 13 <u>rescue squad; or</u>
- 14 (ii) has a need for the cell phone due to the medical
- 15 condition of an immediate family member.
- 16 (2) The school authorities of the public school entity
- 17 approve of the possession and use of the cell phone by the
- 18 student during the school day in a school building of the public
- 19 school entity.
- 20 (c) Each public school entity shall develop or update its
- 21 written policies to implement this section. The written policies
- 22 shall be subject to the approval of the Department of Education.
- 23 (d) As used in this section, the following words and phrases
- 24 shall have the meanings given to them in this subsection:
- 25 "Public school entity" means a school district, independent
- 26 school, area career and technical school, intermediate unit,
- 27 charter school or regional charter school.
- 28 Section 2. This act shall take effect in 60 days.
