AN ACT

Amending Title 18 (Crimes and Offenses) of the Pennsylvania Consolidated Statutes, in abortion, further providing for 2 prohibition against cooperation with out-of-State abortion 3 4 investigations. 5 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 7 Section 1. Title 18 of the Pennsylvania Consolidated 8 Statutes is amended by adding a section to read: § 3208.2. Prohibition against cooperation with out-of-State abortion investigations. 10 11 (a) General rule. -- The applicable individuals and entities 12 in subsection (b) may not provide any information or expend or 13 use time, money, facilities, property, equipment, personnel or 14 other resources in furtherance of any interstate investigation or proceeding seeking to impose civil or criminal liability upon 15 an individual or entity for: 16

(1) The provision, seeking or receipt of or inquiring

- about abortion or its related activities, that are legal in
- 2 this Commonwealth.
- 3 (2) Assisting an individual or entity providing,
- 4 <u>seeking, receiving or responding to an inquiry about abortion</u>
- 5 and its related activities, that are legal in this
- 6 Commonwealth.
- 7 (b) Applicable individuals and entities. -- The prohibition
- 8 contained in subsection (a) shall apply to the following
- 9 individuals and entities:
- 10 (1) A Commonwealth government entity.
- 11 (2) A law enforcement agency.
- 12 <u>(3) A peace officer.</u>
- 13 <u>(4) A political subdivision of the Commonwealth or a</u>
- 14 <u>municipal or any other local authority, including its</u>
- officers, agencies, employees and contractors.
- 16 (c) Exception. -- This section does not apply to an
- 17 investigation or proceeding if the conduct of the investigation
- 18 or proceeding would be a violation of the laws of this
- 19 Commonwealth.
- 20 (d) Definitions. -- As used in this section, the following
- 21 words and phrases shall have the meanings given to them in this
- 22 subsection unless the context clearly indicates otherwise:
- 23 "Commonwealth government entity." Commonwealth government as
- 24 that term is defined in 2 Pa.C.S. § 101 (relating to
- 25 <u>definitions</u>).
- 26 "Law enforcement agency." Any of the following:
- 27 <u>(1) The Pennsylvania State Police.</u>
- 28 (2) The Capitol Police.
- 29 (3) The Harrisburg International Airport Police.
- 30 (4) An airport authority police department.

1	(5) A county park police force under section 2511(b) of
2	the act of August 9, 1955 (P.L.323, No.130), known as The
3	County Code.
4	(6) A public agency of a political subdivision having
5	general police powers and charged with making arrests in
6	connection with the enforcement of the criminal or traffic
7	laws, including the sheriff's office in a county of the
8	second class.
9	(7) A campus police or university police department.
10	(8) A railroad or street railway police department.
11	(9) Any other individual or entity engaged in a law
12	enforcement action.
13	"Peace officer." As defined in section 501 (relating to
14	definitions).
15	Section 2. This act shall take effect in 60 days.
