19	Section 1101. Scope of chapter.
20	This chapter relates to an additional homestead exclusion
21	allocation.
22	Section 1102. Definitions.

- 6 <u>"Homestead property." As defined in 53 Pa.C.S. § 8401</u>
- 7 <u>(relating to definitions).</u>
- 8 <u>Section 1103</u>. Additional property tax reduction allocation.
- 9 (a) Allocation. -- Notwithstanding any other provision of law,
- 10 from Federal funds received by the Commonwealth from the
- 11 American Rescue Plan Act of 2021 (Public Law 117-2, 135 Stat.
- 12 4), a school district shall receive an allocation equal to the
- 13 total number of farmstead properties plus the total number of
- 14 <u>homestead properties in the school district multiplied by \$500.</u>
- 15 (b) Uses.--A school district shall use the allocation under
- 16 subsection (a) to provide an additional exclusion equal to \$500
- 17 per farmstead property and homestead property in the school
- 18 district.
- 19 Section 1104. Appropriation.
- The sum of \$1,332,440,000 of Federal funds in the COVID-19
- 21 Response Restricted Account from the American Rescue Plan Act of
- 22 <u>2021 (Public Law 117-2, 135 Stat. 4) is appropriated to the</u>
- 23 Department of Education for the purpose of making allocations
- 24 under section 1103.
- 25 Section 2. This act shall take effect in 60 days.
