A CONCURRENT RESOLUTION

- Extending in whole the disaster emergency declared on January 28, 2022, in response to the Forbes Avenue/Fern Hollow Bridge
- 3 Collapse.
- 4 WHEREAS, On January 28, 2022, the Governor issued a
- 5 proclamation declaring a disaster emergency in response to the
- 6 collapse of the Forbes Avenue/Fern Hollow Bridge in the City of
- 7 Pittsburgh, Allegheny County; and
- 8 WHEREAS, Multiple vehicles were driving on the bridge at the
- 9 time of the collapse; and
- 10 WHEREAS, Vehicles, motorists and passengers fell
- 11 approximately 100 feet during the collapse; and
- 12 WHEREAS, Motorists and first responders sustained injuries as
- 13 a result of the collapse; and
- 14 WHEREAS, The City of Pittsburgh and surrounding political
- 15 subdivisions continue to experience adverse effects to include
- 16 ongoing traffic disruptions in and around the scene of the
- 17 incident; and
- 18 WHEREAS, These adverse impacts are of such magnitude or

- 1 severity as to render essential the Commonwealth's
- 2 supplementation of county and municipal efforts and resources
- 3 and the activation of all applicable State, county and municipal
- 4 emergency response plans; and
- 5 WHEREAS, Recovery efforts in response to the damage caused by
- 6 the collapse remain ongoing; and
- 7 WHEREAS, Extending the disaster declaration will ensure that
- 8 the Department of Transportation is eligible to receive
- 9 emergency relief funding from the Federal Government to assist
- 10 the City of Pittsburgh; therefore be it
- 11 RESOLVED (the Senate concurring), That the General Assembly
- 12 of the Commonwealth of Pennsylvania, in accordance with section
- 13 20(c) of Article IV of the Constitution of Pennsylvania, extend
- 14 in whole until March 31, 2022, the disaster emergency declared
- 15 on January 28, 2022, in response to the collapse of the Forbes
- 16 Avenue/Fern Hollow Bridge in the City of Pittsburgh, Allegheny
- 17 County, except as terminated or extended, in whole or in part,
- 18 by the General Assembly; and be it further
- 19 RESOLVED, That, upon adoption of this concurrent resolution
- 20 by both chambers of the General Assembly, the Secretary of the
- 21 Senate and the Chief Clerk of the House of Representatives
- 22 notify the Governor of the General Assembly's action; and be it
- 23 further
- 24 RESOLVED, That the Secretary of the Senate and the Chief
- 25 Clerk of the House of Representatives transmit this concurrent
- 26 resolution to the Legislative Reference Bureau for publication
- 27 in the Pennsylvania Bulletin under 45 Pa.C.S. § 725(a)(4); and
- 28 be it further
- 29 RESOLVED, That this concurrent resolution take effect
- 30 immediately.
