## A RESOLUTION

Urging the Pennsylvania School Employees Retirement System, State Employees Retirement System and the Pennsylvania Treasury to immediately divest any and all holdings in 3 Russian held, backed or managed companies, real estate and 4 equity investments and to sever ties with any brokerage firm, bank or investment company held, backed or managed by Russia 6 7 or its citizens. WHEREAS, Russia has attacked its neighbor, the sovereign 8 nation of Ukraine in an act of unprovoked imperialism; and WHEREAS, The United States and its allies have enacted a 10 11 series of economic sanctions designed to inflict economic cost 12 on Russia; and 13 WHEREAS, These sanctions must be strictly enforced to curtail Russia's appetite for further violence; and 14 WHEREAS, Pennsylvania must assist our allies in exacting this 15 16 economic cost; and 17 WHEREAS, Pennsylvania taxpayer dollars may be invested in Russian held, backed, or managed companies, real estate and 18

- 3 backed or managed firms, banks or investment companies;

- 8 immediately divest of any and all holdings in Russian held,
- 9 backed, or managed companies, real estate, and equity
- 10 investments; and be it further
- 11 RESOLVED, That the House of Representatives encourage the
- 12 Pennsylvania School Employees Retirement System, State Employees
- 13 Retirement System and the Pennsylvania Treasury to sever ties
- 14 with any brokerage firm, bank or investment company held,
- 15 backed, or managed by Russia or its citizens.
