- Amending the act of November 10, 1999 (P.L.491, No.45), entitled 1 "An act establishing a uniform construction code; imposing 2 powers and duties on municipalities and the Department of 3 Labor and Industry; providing for enforcement; imposing penalties; and making repeals," in preliminary provisions, 5 further providing for definitions and for application. 6 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows: 9 Section 1. Section 103 of the act of November 10, 1999 10 (P.L.491, No.45), known as the Pennsylvania Construction Code Act, is amended by adding a definition to read: 11 12 Section 103. Definitions. 13 The following words and phrases when used in this act shall have the meanings given to them in this section unless the 14 15 context clearly indicates otherwise: * * * 16 17 "Historical agricultural building." 4	Section 2. Section 104(b) of the act is amended by adding a
5	paragraph to read:

8	(b) ExclusionsThis act shall not apply to any of the
9	following:

11	(4.1) A historical agricultural building, provided that
12	the owner of the building annually files an affidavit with
13	the municipality stating that the following conditions are
14	satisfied or, if the owner fails to do so, the municipality
15	inspects the building at the owner's expense and determines
16	that the following conditions are satisfied:
17	(i) An inspection report by a code administrator
18	states that the building complies with the fire safety
19	provisions for historic buildings of the International
20	Code Council's International Existing Building Code that
21	was part of the Uniform Construction Code at the time of
22	inspection, provided that the building is not required to
23	install an automatic fire sprinkler system.
24	(ii) The building has functioning:
25	(A) hard-wired smoke detectors if electrical
26	wiring has been installed in the interior of the
27	<pre>building; or</pre>
28	(B) battery-powered detectors if electrical
29	wiring has not been installed in the interior of the
30	building.

1	<u>(iii) Portable fire extinguishers are placed in the</u>
2	building consistent with the Uniform Construction Code.
3	(iv) If electrical wiring has been installed in the
4	interior of the building, an inspection report by a code
5	administrator states that the wiring complies with the
6	electrical provisions of the Uniform Construction Code
7	that existed at the time of inspection.
8	(v) Smoking is prohibited in the building.
9	(vi) All open flames are prohibited in the building,
10	except for flames used for the purposes of reheating or
11	maintaining food temperatures and for which the heating
12	source requires no installation as part of the building
13	construction.
14	(vii) The owner maintains for the building liability
15	insurance that is written and issued by an insurer
16	authorized to do business in this Commonwealth.
17	(viii) Signs are posted at the external entrances to
18	all areas of the building used for weddings, receptions
19	and similar social events that state:
20	(A) The maximum occupancy of the building per
21	the requirements of the International Building Code
22	that was part of the Uniform Construction Code at the
23	time of the inspection.
24	(B) "This facility is subject to alternative
25	commercial building and public safety requirements as
26	provided under the Pennsylvania Construction Code
27	Act."
28	(ix) Unless permitted toilet facilities are provided
29	on the grounds of the building, portable toilet
30	facilities are provided in accordance with the minimum

1	number of required toilets for a restaurant or banquet
2	hall in the International Building Code that was part of
3	the Uniform Construction Code at the time of inspection.
4	(x) An inspection report by a code administrator
5	states that the building complies with the accessibility
6	provisions for historic buildings in the International
7	Code Council's International Existing Building Code
8	determined by the Accessibility Advisory Board.
9	(xi) An inspection report by a code administrator
10	states that the building complies with the change of use
11	provisions for historic buildings in the International
12	Code Council's International Existing Building Code that
13	was part of the Uniform Construction Code at the time of
14	inspection.
15	(xii) The primary function remains on the level of
16	exit discharge. The occupancy level of the stories in a
17	multilevel building must be determined by the code
18	administrator and may not exceed levels as determined by
19	the International Building Code that was part of the
20	Uniform Construction Code at the time of inspection.
