AN ACT

- Providing for qualifications of chairperson of the Legislative Reapportionment Commission.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Qualifications of chairperson of Legislative
- 6 Reapportionment Commission.
- 7 (a) Qualifications. -- In addition to the requirements under
- 8 section 17 of Article II of the Constitution of Pennsylvania,
- 9 the chairperson of the Legislative Reapportionment Commission
- 10 must be an individual who:
- 11 (1) Has voted in AT LEAST two of the last three

 12 Statewide general elections immediately preceding the date of

 13 appointment to the Legislative Reapportionment Commission.
- (2) Has not registered, nor has a spouse who has registered, as a Federal or State lobbyist in this Commonwealth in the five years immediately preceding the date
- of appointment to the Legislative Reapportionment Commission.
- 18 (3) Has not been nominated, nor has a spouse who has

- 1 been nominated, as a candidate for elective office in this
- 2 Commonwealth by a political party or political body in the
- 3 five years immediately preceding the date of appointment to
- 4 the Legislative Reapportionment Commission.
- 5 (4) Has not served, nor has a spouse who has served, as
- 6 a staff member or officer of a political party, political
- 7 body, political committee or political action committee in
- 8 this Commonwealth in the five years immediately preceding the
- 9 date of appointment to the Legislative Reapportionment
- 10 Commission.
- 11 (5) Has not served, nor has a spouse who has served, as
- 12 a staff member of an elected official in this Commonwealth in
- the five years immediately preceding the date of appointment
- 14 to the Legislative Reapportionment Commission.
- 15 (b) Ethical standards. -- The provisions of 65 Pa.C.S. Ch. 11
- 16 (relating to ethics standards and financial disclosure) shall
- 17 apply to the Legislative Reapportionment Commission chairperson,
- 18 who shall complete and file a financial disclosure report prior
- 19 to taking office and one year after leaving office.
- 20 Section 2. Application.
- 21 The provisions of section 1 shall apply to the chairperson of
- 22 the Legislative Reapportionment Commission next selected or
- 23 appointed after the effective date of this section.
- 24 Section 3. Effective date.
- This act shall take effect immediately.
