AN ACT

- Amending the act of June 28, 1935 (P.L.477, No.193), entitled "An act providing for the payment of the salary, medical and hospital expenses of certain employes of State and local government who are injured or contract certain diseases in 4 the performance of their duty; and providing that absence during such injury shall not reduce any usual sick leave 7 period," further providing for disability benefits and for definitions. 8 9 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows:

- 23 city, borough, town or township;
- 24 (10.1) firemen employed by the Commonwealth;
- 25 (11) any sheriff or deputy sheriff; [or]
- 26 (12) any enforcement officer or investigator of the
- 27 Pennsylvania Game Commission or the Pennsylvania Fish and Boat
- 28 Commission;
- 29 (13) DCNR Rangers, DCNR Ranger Supervisors, DCNR Ranger
- 30 Operations Specialists, DCNR Ranger Trainees and State Park

- 1 Officers employed by the Department of Conservation and Natural
- 2 Resources;
- 3 (14) members of the Fort Indiantown Gap Police;
- 4 (15) investigative staff of the Office of Inspector General; <--

- 15 (16) members of the Allegheny County Port Authority Police <--
- 16 <u>and transit police officers employed by a participating transit</u>
- 17 or port authority;
- 18 (17) members of the Allegheny County Housing Authority
- 19 Police and housing police officers employed by a participating
- 20 housing authority; or
- 21 (18) corrections officers or jail quards employed by a
- 22 participating county and whose principal duty is the care,
- 23 custody and control of inmates;
- 24 who is injured in the performance of his duties including, in
- 25 the case of firemen, duty as special fire police, and by reason
- 26 thereof is temporarily incapacitated from performing his duties,
- 27 shall be paid by the Commonwealth of Pennsylvania if an employe
- 28 identified under paragraph (1), (2), (3), (4), (4.1), (5),
- 29 <u>(5.1)</u>, (6), (7), (8) [or], (12), (13), (14) or (15) or by the
- 30 Delaware River Port Authority if a member of the Delaware River

- 1 Port Authority Police or by the participating university if a
- 2 campus police officer or by the Allegheny County Port Authority <--
- 3 if a member of the Allegheny County Port Authority Police or by
- 4 <u>a participating transit or port authority if a transit police</u>
- 5 officer or by the Allegheny County Housing Authority if a member
- 6 of the Allegheny County Housing Authority Police or by a
- 7 participating housing authority if a housing police officer or
- 8 by the county, township or municipality, by which he is
- 9 employed, his full rate of salary, as fixed by ordinance or
- 10 resolution, until the disability arising therefrom has ceased.
- 11 All medical and hospital bills, incurred in connection with any
- 12 such injury, shall be paid by the Commonwealth of Pennsylvania
- 13 or by the Delaware River Port Authority or by the participating
- 14 university or by the Allegheny County Port Authority or by the <--
- 15 participating transit or port authority or by the Allegheny
- 16 County Housing Authority or by the participating housing
- 17 authority or by such county, city, township or municipality.
- 18 During the time salary for temporary incapacity shall be paid by
- 19 the Commonwealth of Pennsylvania or by the Delaware River Port
- 20 Authority or by the participating university or by the Allegheny <--
- 21 County Port Authority or by the participating transit or port
- 22 authority or by the Allegheny County Housing Authority or by the
- 23 participating housing authority or by the county, city, borough,
- 24 town or township, any workmen's compensation, received or
- 25 collected by any such employe for such period, shall be turned
- 26 over to the Commonwealth of Pennsylvania or to the Delaware
- 27 River Port Authority or to the participating university or to
- 28 the Allegheny County Port Authority or to the participating
- 29 transit or port authority or to the Allegheny County Housing
- 30 Authority or to the participating housing authority or to such

- 2 treasury thereof, and if such payment shall not be so made by

- 14 (3) the parole agents, enforcement officers and

- 16 (3.1) probation officers employed by a participating county;
- 17 (4) Capitol Police officers;
- 18 (4.1) campus police officers employed by a participating
- 19 university;
- 20 (5) correction employes employed by the Department of

- 26 (16) members of the Allegheny County Port Authority Police <--
- 27 <u>and transit police officers employed by a participating transit</u>
- 28 <u>or port authority;</u>
- 29 (17) members of the Allegheny County Housing Authority
- 30 Police and housing police officers employed by a participating

- 1 housing authority; and
- 2 (18) corrections officers or jail quards employed by a
- 3 participating county and whose principal duty is the care,
- 4 custody and control of inmates;
- 5 who have served for four consecutive years or longer, diseases
- 6 of the heart and tuberculosis of the respiratory system,
- 7 contracted or incurred by any of them after four years of
- 8 continuous service as such, and caused by extreme overexertion
- 9 in times of stress or danger or by exposure to heat, smoke,
- 10 fumes or gases, arising directly out of the employment shall be
- 11 compensable in accordance with the terms hereof; and unless any
- 12 such disability shall be compensable under the compensation laws
- 13 as having been caused by accidental injury, such disability
- 14 shall be compensable as occupational disease disabilities are
- 15 presently compensable under the compensation laws of this
- 16 Commonwealth. It shall be presumed that tuberculosis of the
- 17 respiratory system contracted or incurred after four consecutive
- 18 years of service was contracted or incurred as a direct result
- 19 of employment.
- 20 (c) In the case of any person receiving benefits pursuant to
- 21 this act, the statutes of limitations set forth in sections
- 22 306.1, 315, 413, and 434 of the act of June 2, 1915 (P.L.736,
- 23 No.338), known as the "Workers' Compensation Act," shall not
- 24 begin to run until the expiration of the receipt of benefits
- 25 pursuant to this act.
- 26 (d) (1) All payments herein required to be made by the
- 27 Commonwealth of Pennsylvania on account of any member of the
- 28 State Police Force shall be made from moneys appropriated to the
- 29 Pennsylvania State Police.
- 30 (2) Any payments required to be made on account of any

- 1 enforcement officer or investigator employed by the Pennsylvania
- 2 Liquor Control Board shall be made from appropriations out of
- 3 the State Stores Fund.
- 4 (3) Any payments required to be made on account of any
- 5 parole agent, enforcement officer or investigator employed by
- 6 the Pennsylvania Board of Probation and Parole shall be made
- 7 from moneys appropriated to the Pennsylvania Board of Probation
- 8 and Parole.
- 9 (4) Any payments required to be made on account of Capitol
- 10 Police officers shall be made from moneys appropriated to the
- 11 Department of General Services.
- 12 (5) Any payments required to be made on account of any
- 13 correction employe or any commissioned police officer employed
- 14 by the Department of Corrections, Bureau of Investigations and
- 15 <u>Intelligence</u>, shall be made from moneys appropriated to the
- 16 Department of Corrections.
- 17 (6) Any payments required to be made on account of any
- 18 psychiatric security aides shall be made from moneys
- 19 appropriated to the Department of Human Services or the
- 20 Department of Corrections where appropriate.
- 21 (6.1) Any payments required to be made on account of any
- 22 <u>campus police officers employed by a participating university</u>
- 23 shall be made from moneys appropriated to the participating
- 24 university.
- 25 (6.2) Any payments required to be made on account of any
- 26 DCNR Rangers, DCNR Ranger Supervisors, DCNR Ranger Operations
- 27 Specialists, DCNR Ranger Trainees and State Park Officers
- 28 employed by the Department of Conservation and Natural Resources
- 29 shall be made from moneys appropriated to the Department of
- 30 Conservation and Natural Resources.

- 1 (6.3) Any payments required to be made on account of any
- 2 members of the Fort Indiantown Gap Police Force employed by the
- 3 <u>Department of Military and Veterans Affairs shall be made from</u>
- 4 moneys appropriated to the Department of Military and Veterans
- 5 Affairs.
- 6 (6.4) Any payments required to be made on account of any
- 7 <u>investigative staff of the Office of Inspector General WELFARE</u> <--
- 8 FRAUD INVESTIGATOR, WELFARE FRAUD INVESTIGATOR SUPERVISOR,
- 9 CLAIMS INVESTIGATION AGENT OR CLAIMS INVESTIGATION AGENT
- 10 SUPERVISOR EMPLOYED BY THE OFFICE OF STATE INSPECTOR GENERAL
- 11 <u>shall be made from moneys appropriated to the Office of</u>

- 27 <u>members of the Allegheny County Housing Authority Police shall</u>
- 28 be made from any moneys appropriated to the Allegheny County
- 29 <u>Housing Authority</u>.
- 30 (6.8) Any payments required to be made on account of any

- 1 members of a participating housing authority shall be made from
- 2 moneys appropriated to the housing authority.
- 3 (7) Any payments required to be made on account of any drug
- 4 enforcement agent or special agents shall be made from moneys
- 5 appropriated to the Office of Attorney General and any payments
- 6 required to be made on account of any fireman employed by the
- 7 Commonwealth shall be made from moneys appropriated to the
- 8 employing agency.
- 9 (8) Any payments required to be made on account of any
- 10 enforcement officers or investigators of the Pennsylvania Game
- 11 Commission shall be made from moneys appropriated to the
- 12 Pennsylvania Game Commission or executively authorized from the
- 13 Game Fund under 34 Pa.C.S. Ch. 5 Subch. B (relating to Game
- 14 Fund).
- 15 (9) Any payments required to be made on account of any
- 16 enforcement officers or investigators of the Pennsylvania Fish
- 17 and Boat Commission shall be made from moneys appropriated to
- 18 the Pennsylvania Fish and Boat Commission or executively
- 19 authorized from the Fish Fund under 30 Pa.C.S. Ch. 5 Subch. B
- 20 (relating to the Fish Fund) or the Boat Fund under 30 Pa.C.S.
- 21 Ch. 5 Subch. C (relating to the Boat Fund).
- 22 Section 2.1. For the purposes of this act, the [term
- 23 "fireman" shall mean and include the following:] following words
- 24 and phrases shall have the meanings given to them in this
- 25 section unless the context clearly indicates otherwise:
- 26 <u>"Fireman."</u> Any of the following:
- 27 (1) Paid firemen not employed by the Commonwealth.
- 28 (2) Emergency medical services personnel employed within a
- 29 city fire department.
- 30 (3) Firemen of airport authorities, including fire

- 1 suppression instructors.
- 2 (4) Fire and safety marshals who are firemen employed by the
- 3 Commonwealth.
- 4 (5) Fire academy instructors employed at the State Fire
- 5 Academy.
- 6 (6) Assistant fire marshals employed by the Commonwealth.
- 7 (7) [Forest patrolmen and forest technicians] Forest fire
- 8 wardens or wildland firefighters employed by the Commonwealth.
- 9 "Participating county." A county that elects or bargains to

- 11 of Labor and Industry, POSTING A NOTICE ON THE COUNTY'S PUBLICLY <--
- 12 ACCESSIBLE INTERNET WEBSITE, which election shall be irrevocable
- 13 <u>after participation in this act commences.</u>
- 14 "Participating housing authority." A housing authority that
- 15 <u>elects or bargains to participate in this act by submitting a</u> <-
- 16 <u>notice to the Department of Labor and Industry, POSTING A NOTICE_</u><--
- 17 ON THE HOUSING AUTHORITY'S PUBLICLY ACCESSIBLE INTERNET WEBSITE,
- 18 which election shall be irrevocable after participating in this
- 19 <u>act commences.</u>
- 20 "Participating transit or port authority." A transit or port
- 21 authority that elects or bargains, IN ITS SOLE AND EXCLUSIVE <-
- 22 DISCRETION, to participate in this act by submitting a notice to <--
- 23 the Department of Labor and Industry, POSTING A NOTICE ON THE <--
- 24 TRANSIT OR PORT AUTHORITY'S PUBLICLY ACCESSIBLE INTERNET
- 25 WEBSITE, which election shall be irrevocable after participating
- 26 in this act commences.
- 27 <u>"Participating university." Any of the following that elects</u>
- 28 or bargains to participate in this act by submitting a notice to <--
- 29 <u>the Department of Labor and Industry, POSTING A NOTICE ON THE</u>
- 30 UNIVERSITY'S PUBLICLY ACCESSIBLE INTERNET WEBSITE, which

- 1 <u>election shall be irrevocable after participation in this act</u>
- 2 <u>commences:</u>
- 3 <u>(1) A State-owned university.</u>
- 4 (2) A community college.
- 5 (3) A State-related college or university.
- 6 (4) A State-aided college or university.
- 7 Section 2. This act shall take effect in 60 120 days. <--
