AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in school health services, providing for seizure management and treatment plan, for seizure 6 recognition and related first aid training, for seizure disorder management and first aid liability, for acts not 7 8 considered delegation for seizure disorder care and for 9 10 liability. The General Assembly of the Commonwealth of Pennsylvania 11 12 hereby enacts as follows: 13 Section 1. This act may be referred to as Haley's Law. 14 Section 2. The act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, is amended by adding sections 15 16 to read: 17 Section 1414.11. Seizure Management and Treatment Plan. -- (a) 18 The parent or quardian of a student with a seizure disorder may 19 seek care for the student's seizures while the student is at 20 school or participating in a school activity by submitting to the school entity where the student is enrolled a copy of a 21

seizure management and treatment plan developed by the parent or

- 1 <u>quardian and the family physician responsible for the student's</u>
- 2 <u>seizure management and treatment.</u>
- 3 (b) The seizure management and treatment plan submitted
- 4 under subsection (a) must be reviewed by the school entity to
- 5 determine if the plan satisfies the criteria under subsection
- 6 <u>(c):</u>
- 7 (1) before or at the beginning of the school year;
- 8 (2) on the date of the enrollment of the student if the
- 9 student enrolls in the school entity after the beginning of the
- 10 school year; or
- 11 (3) as soon as practicable following a diagnosis of a
- 12 <u>seizure disorder for the student.</u>
- 13 (c) A seizure management and treatment plan shall:
- 14 (1) identify the health care services that the student may
- 15 receive while at school or participating in a school activity;
- 16 (2) evaluate the student's ability to manage the ongoing
- 17 maintenance of the student's seizure disorder; and
- 18 (3) be signed by the student's parent or quardian and the
- 19 family physician responsible for the student's seizure
- 20 <u>management and treatment.</u>
- 21 (d) As used in this section, "school entity" means any
- 22 <u>public school, charter school, cyber charter school, private</u>
- 23 school, nonpublic school, intermediate unit or area vocational-
- 24 <u>technical school</u>.
- 25 Section 1414.12. Seizure Recognition and Related First Aid
- 26 Training. -- (a) A school nurse may complete an online or in-
- 27 person course of instruction approved by the Department of
- 28 Education, in conjunction with the Department of Health, for
- 29 <u>school nurses regarding managing students with seizure disorders</u>
- 30 that includes information about seizure recognition and related

- 1 first aid.
- 2 (b) A school employe may complete an online or in-person
- 3 course of instruction approved by the Department of Education,
- 4 <u>in conjunction with the Department of Health, for school</u>
- 5 personnel regarding awareness of students with seizure disorders
- 6 and information about seizure recognition and related first aid.
- 7 A school employe who completes the online or in-person course of
- 8 <u>instruction under this subsection shall be eliqible for credit</u>
- 9 towards the continuing professional education requirements under
- 10 section 1205.2(a)(3) and (4). Completion of seizure disorder
- 11 training under this subsection shall not be construed to
- 12 <u>obligate a school employe to administer medication or provide</u>
- 13 medical care to a student with a seizure disorder.
- 14 (c) The Department of Education, in conjunction with the
- 15 Department of Health, may approve an online or in-person course
- 16 of instruction provided by a nonprofit organization that
- 17 supports the welfare of individuals with epilepsy and seizure
- 18 <u>disorders</u>. An online or in-person course of instruction approved
- 19 <u>under this subsection shall be provided to a school entity by a</u>
- 20 <u>nonprofit organization at no cost.</u>
- 21 (d) The Department of Education, in conjunction with the
- 22 Department of Health, shall approve online and in-person courses
- 23 of instruction no later than July 1, 2021.
- 24 (e) The Department of Education, in conjunction with the
- 25 Department of Health, shall adopt rules as necessary to
- 26 administer this section.
- 27 <u>(f) As used in this section, "school entity" means any</u>
- 28 <u>public school, charter school, cyber charter school, private</u>
- 29 school, nonpublic school, intermediate unit or area vocational-
- 30 technical school.

- 1 <u>Section 1414.13. Seizure Disorder Management and First Aid</u>
- 2 <u>Liability.--(a) Nothing in the provisions under sections</u>
- 3 1414.11 and 1414.12 shall be construed to establish or expand
- 4 any civil liability on the part of a school entity or school
- 5 <u>employe</u>.
- 6 (b) As used in this section, "school entity" means any
- 7 <u>public school, charter school, cyber charter school, private</u>
- 8 school, nonpublic school, intermediate unit or area vocational-
- 9 <u>technical school</u>.
- 10 <u>Section 1414.14. Acts Not Considered Delegation for Seizure</u>
- 11 <u>Disorder Care.--(a) Notwithstanding any other law to the</u>
- 12 contrary, coordinating or supervising the provision of seizure
- 13 <u>disorder care under section 1414.11 and providing instruction</u>
- 14 <u>under section 1414.12 shall not be construed as a delegation by</u>
- 15 <u>a health care practitioner.</u>
- 16 (b) Notwithstanding any other provision of law, a school
- 17 <u>employe who receives seizure disorder care training under</u>
- 18 section 1414.12(b) shall not be considered to be engaging in
- 19 <u>health-related activities which are reserved exclusively for</u>
- 20 licensed professionals.
- 21 <u>Section 1414.15. Liability.--(a) A school district or</u>
- 22 school district employe or agent, acting in good faith and in
- 23 <u>substantial compliance with a student's seizure management and</u>
- 24 treatment plan and the instructions of the student's family
- 25 physician, shall not be subject to any criminal or civil
- 26 <u>liability or any professional disciplinary action.</u>
- 27 (b) A health care practitioner who acts in accordance with
- 28 section 1414.11 when coordinating or supervising care for a
- 29 <u>student and in accordance with section 1414.12 when providing</u>
- 30 <u>instruction to a school employe shall not be subject to any</u>

- 1 <u>criminal or civil liability or any professional disciplinary</u>
- 2 <u>action</u>.
- 3 Section 3. The addition of sections 1414.11, 1414.12,
- 4 1414.13, 1414.14 and 1414.15 of the act shall apply to the 2021-
- 5 2022 school year and each school year thereafter.
- 6 Section 4. This act shall take effect in 60 days.
