AN ACT

- Amending Titles 18 (Crimes and Offenses) and 35 (Health and Safety) of the Pennsylvania Consolidated Statutes, in cruelty
- to animals, further providing for police animals; and, in
- 4 emergency medical services system, providing for injured
- 5 police animals.
- 6 This act may be referred to as Titan's Law.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 5548(c) of Title 18 of the Pennsylvania
- 10 Consolidated Statutes is amended and the section is amended by
- 11 adding subsections to read:
- 12 § 5548. Police animals.
- 13 * * *
- (b.1) Injury or death. -- It shall be unlawful for a person to
- 15 cause serious bodily injury or death to a police animal while
- 16 engaged as a principal or an accomplice in the perpetration of a
- 17 felony. A person who violates the provisions of this subsection
- 18 commits a felony of the second degree.
- 19 (c) Restitution.--In a case in which a defendant is

- 1 convicted of a violation of subsection (a) [or (b)], (b) or
- 2 (b.1), the defendant shall be ordered to make restitution to the
- 3 agency or individual owning the animal for veterinary bills, for
- 4 replacement costs of the animal if it is disabled or killed and
- 5 for the salary of the animal's handler for the period of time
- 6 the handler's services are lost to the agency.
- 7 (d) Definition. -- As used in this section, the following
- 8 words and phrases shall have the meanings given to them in this
- 9 <u>subsection unless the context clearly indicates otherwise:</u>
- 10 "Perpetration of a felony." An act of a defendant to commit,
- 11 attempt, flee from, conspire or be an accomplice or an accessory
- 12 after the fact to any of the following offenses:
- 13 (1) Section 2702 (relating to aggravated assault).
- 14 (2) Section 2702.1 (relating to assault of law
- enforcement officer).
- 16 (3) Section 2901 (relating to kidnapping).
- 17 (4) Section 3121 (relating to rape).
- 18 (5) Section 3123 (relating to involuntary deviate sexual
- 19 intercourse).
- 20 (6) Section 3301 (relating to arson and related
- offenses).
- 22 (7) Section 3502 (relating to burglary).
- 23 (8) Section 3701 (relating to robbery).
- 24 (9) A violation of the act of April 14, 1972 (P.L.233,
- No.64), known as The Controlled Substance, Drug, Device and
- 26 Cosmetic Act.
- 27 Section 2. Title 35 is amended by adding a section to read:
- 28 § 8158. Injured police animals.
- 29 <u>(a) Transportation.--An emergency services provider or a</u>
- 30 police officer may transport a police animal injured in the line

- 1 of duty to a veterinary clinic, hospital emergency department or
- 2 similar facility if there is no individual requiring immediate
- 3 medical attention or transport at that time.
- 4 (b) Emergency medical care. -- An emergency services provider
- 5 may provide emergency medical care to a police animal injured in
- 6 the line of duty while at the scene of the emergency or while
- 7 the police animal is being transported to a veterinary clinic,
- 8 <u>hospital emergency department or similar facility.</u>
- 9 (c) Definitions.--As used in this section, the following
- 10 words and phrases shall have the meanings given to them in this
- 11 subsection unless the context clearly indicates otherwise:
- 12 "Police animal." As defined in 18 Pa.C.S. § 5531 (relating
- 13 to definitions).
- 14 Section 3. This act shall take effect immediately.
