AN ACT

Amending the act of November 24, 1998 (P.L.882, No.111), entitled "An act providing for victims' rights; imposing penalties; establishing remedies; establishing the Office of Victim Advocate, the Bureau of Victims' Services, the Victims' Services Advisory Committee, the State Offender 5 Supervision Fund and other funds; and making repeals," in preliminary provisions, further providing for definitions; in crime victims, further providing for rights, for 8 responsibilities of victims of crime under basic bill of 9 rights, for responsibilities of State and local law 10 enforcement agencies, for responsibilities of prosecutor's 11 office, FOR RESPONSIBILITIES OF DEPARTMENT, LOCAL 12 CORRECTIONAL FACILITIES AND BOARD and for responsibilities of 13 juvenile probation office; in administration, further 14 15 providing for office, for powers and duties of victim advocate and for powers and duties of Office of Victims' 16 17 Services; in compensation, further providing for persons eligible for compensation, PROVIDING FOR COUNSELING SERVICES <--18 FOR VICTIMS OF SEXUAL ABUSE AND FURTHER PROVIDING for filing 19 of claims for compensation, for minimum allowable claim, for 20 21 determination of claims, for emergency awards, for awards and for confidentiality of records; in services, further 22 providing for eligibility of victims; in financial matters, 23 further providing for costs and for costs for offender 24 supervision programs; and, in enforcement, further providing <--25 for subrogation and for revictimization relief; TRANSFERRING <--26 27 MONEY FROM THE CRIME VICTIM'S COMPENSATION FUND; PROVIDING FOR APPLICABILITY; AND MAKING A RELATED REPEAL. 28
