11	Section 1. Section 5803(a) of Title 42 of the Pennsylvania
12	Consolidated Statutes is amended by adding a paragraph to read:
13	§ 5803. Asset forfeiture.
14	(a) ApplicabilityNotwithstanding any law to the contrary,
15	this section shall apply to forfeitures conducted under the
16	following:

- 1 Section 2. Section 7721 of Title 75 is amended to read:
- 2 § 7721. Operation on streets and highways.
- 3 (a) General rule. -- Except as otherwise provided in this-
- 4 chapter, it is unlawful to operate a snowmobile, dirt bike or an-
- 5 ATV on any street or highway which is not designated and posted
- 6 as a snowmobile, dirt bike or an ATV road by the governmental
- 7 agency having jurisdiction.
- 8 (b) Emergency and bridge crossings. A snowmobile, dirt bike
- 9 or an ATV may be operated on highways and streets:
- 10 (1) During periods of emergency when so declared by a
- 11 policy agency having jurisdiction.
- 12 (2) When necessary to cross a bridge or culvert.
- (c) Crossing street or highway. A snowmobile, dirt bike or
- 14 an ATV may make a direct crossing of a street or highway upon
- 15 compliance with the following requirements:
- 16 (1) The crossing is made at an angle of approximately 90
- 17 degrees to the direction of the highway and at a place where-
- 18 no obstruction prevents a quick and safe crossing.
- 19 (2) The snowmobile, dirt bike or ATV is brought to a
- 20 complete stop before crossing the shoulder or main-traveled
- 21 way of the highway.
- 22 (3) The driver yields the right of way to all oncoming
- 23 traffic which constitutes an immediate hazard.
- 24 (4) In crossing a divided highway, the crossing is made
- 25 only at an intersection of such highway with another public
- 26 street or highway.
- 27 (d) Penalties. Except as provided under subsection (e), a
- 28 dirt bike or all terrain vehicle operated on any public street,
- 29 highway or right-of-way in a city of the first class, second-
- 30 class, second class A or third class or a borough in violation

- 1 of this section shall be designated as prima facie contraband
- 2 subject to forfeiture in accordance with 42 Pa.C.S. § 5803
- 3 <u>(relating to asset forfeiture).</u>
- 4 (e) Applicability. The provisions of subsection (d) do not
- 5 apply to a city of the first class, second class, second class A
- 6 or third class or borough that has adopted an ordinance allowing
- 7 for the operation of an ATV within the city of the first class,
- 8 second class, second class A or third class or borough in
- 9 <u>accordance with section 7722(a) (relating to designation of</u>
- 10 snowmobile and ATV roads) or 7724(b) (relating to operation on
- 11 <u>private or State property).</u>
- 12 <u>(f) Definitions. As used in this section, the following</u>
- 13 words and phrases shall have the meanings given to them in this
- 14 <u>subsection unless the context clearly indicates otherwise:</u>
- 15 <u>"Dirt bike." A two-wheeled motorcycle that is designed and</u>
- 16 <u>manufactured for off road use only and that does not comply with</u>
- 17 Federal motor vehicle safety standards or United States
- 18 Environmental Protection Agency on road emissions standards.

- 22 SECTION 2. TITLE 75 IS AMENDED BY ADDING A SECTION TO READ:
- 23 § 3721. OFF-ROAD VEHICLES IN URBAN MUNICIPALITIES.
- 24 (A) PROHIBITION. -- EXCEPT AS PROVIDED IN SUBCHAPTER C OF
- 25 CHAPTER 77 (RELATING TO OPERATION), SUBSECTION (B) OR OTHERWISE
- 26 PROVIDED BY THIS TITLE OR OTHER LAW OF THIS COMMONWEALTH,
- 27 INCLUDING LOCAL ORDINANCES ADOPTED BY URBAN MUNICIPALITIES, NO <--
- 28 INDIVIDUAL MAY OPERATE AN ALL-TERRAIN VEHICLE OR A DIRT BIKE ON
- 29 ANY OF THE FOLLOWING PUBLIC AREAS WITHIN THE BOUNDARIES OF AN
- 30 URBAN MUNICIPALITY:

- 1 (1) A HIGHWAY, INCLUDING THE BERM OR SHOULDER.
- 2 (2) A SIDEWALK.
- 3 (3) A PEDALCYCLE LANE.
- 4 (B) EXCEPTION FOR CROSSING. -- SUBSECTION (A) SHALL NOT APPLY
- 5 TO THE OPERATION OF A DIRT BIKE WHILE MAKING A DIRECT CROSSING
- 6 OF A HIGHWAY IN COMPLIANCE WITH ALL OF THE FOLLOWING
- 7 REOUIREMENTS:
- 8 <u>(1) THE CROSSING IS MADE AT AN ANGLE OF APPROXIMATELY 90</u>
- 9 <u>DEGREES TO THE DIRECTION OF THE HIGHWAY AND AT A PLACE WHERE</u>
- 10 NO OBSTRUCTION PREVENTS A QUICK AND SAFE CROSSING.
- 11 (2) THE DIRT BIKE IS BROUGHT TO A COMPLETE STOP BEFORE
- 12 CROSSING THE SHOULDER OR MAIN-TRAVELED WAY OF THE HIGHWAY.
- 13 (3) THE INDIVIDUAL YIELDS THE RIGHT-OF-WAY TO ALL
- 14 <u>ONCOMING TRAFFIC WHICH CONSTITUTES AN IMMEDIATE HAZARD.</u>
- 15 (4) IN CROSSING A DIVIDED HIGHWAY, THE CROSSING IS MADE
- 16 ONLY AT AN INTERSECTION OF THE HIGHWAY WITH ANOTHER HIGHWAY.
- 17 (C) PENALTY.--EXCEPT AS PROVIDED IN SUBSECTION (D), AN
- 18 INDIVIDUAL WHO VIOLATES SUBSECTION (A) COMMITS A SUMMARY OFFENSE
- 19 AND SHALL, UPON CONVICTION:
- 20 (1) FOR A FIRST OFFENSE, BE SENTENCED TO PAY A FINE OF
- 21 NOT LESS THAN \$50 NOR MORE THAN \$200 AND COSTS OF PROSECUTION
- 22 AND, IN DEFAULT OF THE PAYMENT OF THE FINE OR COSTS, BE
- 23 IMPRISONED FOR NOT MORE THAN 10 DAYS.
- 24 (2) FOR A SUBSEQUENT OFFENSE, BE SENTENCED TO PAY A FINE
- 25 OF NOT LESS THAN \$100 NOR MORE THAN \$300 AND COSTS OF
- 26 PROSECUTION AND, IN DEFAULT OF THE PAYMENT OF THE FINE OR
- 27 COSTS, BE IMPRISONED FOR NOT MORE THAN 30 DAYS.
- 28 (D) PROHIBITION ON SIMILAR CITATIONS.--NO PERSON MAY BE
- 29 CHARGED WITH A VIOLATION OF SUBCHAPTER C OF CHAPTER 77
- 30 CONCURRENTLY WITH A VIOLATION OF SUBSECTION (A) FOR AN OFFENSE

- 1 COMMITTED AT THE SAME TIME AND PLACE.
- 2 (E) FORFEITURE. AN ALL TERRAIN VEHICLE OR DIRT BIKE
- 3 OPERATED IN VIOLATION OF SUBSECTION (A) SHALL BE DESIGNATED
- 4 PRIMA FACIE CONTRABAND SUBJECT TO FORFEITURE IN ACCORDANCE WITH
- 5 42 PA.C.S. § 5803 (RELATING TO ASSET FORFEITURE).
- 6 (E) FORFEITURE.--

- 7 (1) IN ADDITION TO THE PENALTY PROVIDED UNDER SUBSECTION
- 8 (C) AND SUBJECT TO PARAGRAPH (2), AN ALL-TERRAIN VEHICLE OR
- 9 <u>DIRT BIKE OPERATED IN VIOLATION OF SUBSECTION (A) SHALL BE</u>
- 10 SUBJECT TO FORFEITURE IN ACCORDANCE WITH 42 PA.C.S. §§ 5803
- 11 (RELATING TO ASSET FORFEITURE), 5805 (RELATING TO FORFEITURE
- PROCEDURE), 5806 (RELATING TO MOTION FOR RETURN OF PROPERTY),
- 13 5807 (RELATING TO RESTRICTIONS ON USE), 5807.1 (RELATING TO

- 16 (2) FORFEITURE AS AUTHORIZED UNDER PARAGRAPH (1) MAY NOT
- 17 OCCUR UNLESS THE INDIVIDUAL IS CONVICTED OF A VIOLATION OF
- 18 SUBSECTION (A).
- 19 (3) A POLICE OFFICER MAY IMPOUND AN ALL-TERRAIN VEHICLE
- OR DIRT BIKE OPERATED IN VIOLATION OF SUBSECTION (A) PENDING
- 21 FINAL DISPOSITION OF THE CASE OR A COURT ORDER.
- 22 (F) CONSTRUCTION. -- NOTHING CONTAINED IN THIS SECTION SHALL
- 23 BE CONSTRUED TO ALLOW THE OPERATION OF AN ALL-TERRAIN VEHICLE OR
- 24 DIRT BIKE OUTSIDE OF THE BOUNDARIES OF AN URBAN MUNICIPALITY IN
- 25 A MANNER THAT IS INCONSISTENT WITH THIS TITLE OR OTHER LAW OF
- 26 THIS COMMONWEALTH.
- 27 (G) DEFINITIONS.--AS USED IN THIS SECTION, THE FOLLOWING
- 28 WORDS AND PHRASES SHALL HAVE THE MEANINGS GIVEN TO THEM IN THIS
- 29 SUBSECTION UNLESS THE CONTEXT CLEARLY INDICATES OTHERWISE:
- 30 "ALL-TERRAIN VEHICLE." AS DEFINED IN SECTION 7702 (RELATING

- 1 TO DEFINITIONS).
- 2 "DIRT BIKE." A TWO-WHEELED MOTOR VEHICLE THAT HAS A SEAT OR
- 3 SADDLE, IS DESIGNED AND MANUFACTURED EXCLUSIVELY FOR OFF-ROAD
- 4 <u>USE AND DOES NOT COMPLY WITH FEDERAL MOTOR VEHICLE SAFETY</u>
- 5 STANDARDS OR ENVIRONMENTAL PROTECTION AGENCY ON-ROAD EMISSIONS
- 6 STANDARDS. THE TERM DOES NOT INCLUDE:
- 7 (1) A VEHICLE THAT IS OR IS REQUIRED TO BE REGISTERED
- 8 UNDER CHAPTER 13 (RELATING TO REGISTRATION OF VEHICLES).
- 9 <u>(2) A DUAL SPORT MOTORCYCLE.</u>
- 10 (3) AN ELECTRIC PEDALCYCLE.
- "DUAL SPORT MOTORCYCLE." A MOTORCYCLE THAT IS DESIGNED AND
- 12 MANUFACTURED TO BE RIDDEN ON AND OFF ROAD AND MAY OR MAY NOT BE <--
- 13 REGISTERED WITH THE DEPARTMENT IS TITLED AND REGISTERED WITH THE <--
- 14 DEPARTMENT FOR ON-ROAD USE.
- 15 "ELECTRIC PEDALCYCLE." A VEHICLE THAT:
- 16 (1) WEIGHS NOT MORE THAN 100 POUNDS WITH TWO WHEELS MORE
- 17 THAN 11 INCHES IN DIAMETER;
- 18 (2) IS MANUFACTURED OR ASSEMBLED WITH AN ELECTRIC MOTOR
- 19 SYSTEM RATED AT NOT MORE THAN 750 WATTS AND THAT CEASES TO
- 20 PROVIDE ASSISTANCE WHEN THE VEHICLE REACHES SPEEDS OF 28
- 21 MILES PER HOUR; AND
- 22 (3) IS EQUIPPED WITH OPERABLE PEDALS AND A SEAT OR
- 23 SADDLE FOR THE RIDER.
- 24 "URBAN MUNICIPALITY." A CITY OF THE FIRST CLASS, SECOND
- 25 CLASS, SECOND CLASS A, THIRD CLASS OR A BOROUGH A OR THIRD
- 26 CLASS.
- 27 SECTION 3. THE DEFINITION OF "ALL-TERRAIN VEHICLE" OR "ATV"
- 28 IN SECTION 7702 OF TITLE 75 IS AMENDED TO READ:
- 29 § 7702. DEFINITIONS.
- 30 THE FOLLOWING WORDS AND PHRASES WHEN USED IN THIS CHAPTER

- 1 SHALL HAVE, UNLESS THE CONTEXT CLEARLY INDICATES OTHERWISE, THE
- 2 MEANINGS GIVEN TO THEM IN THIS SECTION:
- 3 "ALL-TERRAIN VEHICLE" OR "ATV." A MOTORIZED OFF-HIGHWAY
- 4 VEHICLE WHICH TRAVELS ON THREE OR MORE [OFF-HIGHWAY] TIRES AND
- 5 WHICH HAS:
- 6 (1) A MAXIMUM WIDTH OF 50 INCHES AND A MAXIMUM DRY
- 7 WEIGHT OF 1,200 POUNDS; OR
- 8 (2) A WIDTH WHICH EXCEEDS 50 INCHES OR A DRY WEIGHT
- 9 WHICH EXCEEDS 1,200 POUNDS.
- 10 [ATV'S] AN ATV DESCRIBED IN PARAGRAPH (1) MAY BE REFERRED TO AS
- 11 A CLASS I [ATV'S] ATV, AND [ATV'S] AN ATV DESCRIBED IN PARAGRAPH
- 12 (2) MAY BE REFERRED TO AS A CLASS II [ATV'S] ATV. THIS TERM DOES
- 13 NOT INCLUDE SNOWMOBILES, TRAIL BIKES, MOTORBOATS, GOLF CARTS,
- 14 AIRCRAFT, DUNE BUGGIES, AUTOMOBILES, CONSTRUCTION MACHINES,
- 15 TRUCKS OR HOME UTILITY MACHINES; MILITARY, FIRE, EMERGENCY AND
- 16 LAW ENFORCEMENT VEHICLES; IMPLEMENTS OF HUSBANDRY; MULTIPURPOSE
- 17 AGRICULTURAL VEHICLES; VEHICLES USED BY THE DEPARTMENT; OR ANY
- 18 VEHICLE THAT IS OR IS REQUIRED TO BE REGISTERED UNDER CHAPTER 13
- 19 (RELATING TO REGISTRATION OF VEHICLES). IN ADDITION, THIS TERM
- 20 DOES NOT INCLUDE OFF-ROAD MOTOR VEHICLES USED EXCLUSIVELY AS
- 21 UTILITY VEHICLES FOR AGRICULTURAL OR BUSINESS OPERATIONS AND
- 22 INCIDENTALLY OPERATED OR MOVED UPON THE HIGHWAY.
