A RESOLUTION

- Petitioning the Congress of the United States to extend daylight saving time throughout the year across the country.
- 3 WHEREAS, The Congress of the United States has adopted
- 4 various versions of daylight saving time since 1918, when the
- 5 policy originated to support the war industries; and
- 6 WHEREAS, Continuous daylight saving time was observed during
- 7 World War II, referred to as War Time, and was reinstated during
- 8 the 1973 oil embargo; and
- 9 WHEREAS, Daylight saving time is a policy issue for many
- 10 states; and
- 11 WHEREAS, State legislation that provides for advances in time
- 12 or changeover dates is superseded to the extent it differs from
- 13 Federal law under 15 U.S.C. § 260a; and
- 14 WHEREAS, The United States Secretary of Transportation
- 15 enforces uniform application of 15 U.S.C. § 260a across all time
- 16 zones; and
- 17 WHEREAS, Arizona, except for its Navajo Nation residents,
- 18 Hawaii and the insular territories are exempt from the biannual

- 1 time changes; and
- 2 WHEREAS, Congress has noted such benefits as more daylight,
- 3 increased outdoor playtime for the children and youth of our
- 4 nation, greater utilization of parks and recreation areas and
- 5 expanded economic opportunity through extension of daylight
- 6 hours to peak shopping hours; and
- 7 WHEREAS, Federal Government analysts have further identified
- 8 positive effects relating to energy savings, traffic safety and
- 9 crime reduction; and
- 10 WHEREAS, The Sunshine Protection Act of 2021, introduced in
- 11 the 117th Congress, would institute permanent daylight saving
- 12 time nationwide; and
- 13 WHEREAS, Without congressional action, daylight saving time
- 14 ends November 7, 2021, and resumes March 14, 2021; therefore be
- 15 it
- 16 RESOLVED, That the Senate of the Commonwealth of Pennsylvania
- 17 petition the Congress of the United States to extend daylight
- 18 saving time throughout the year across the country; and be it
- 19 further
- 20 RESOLVED, That copies of this resolution be transmitted to
- 21 the presiding officers of each house of Congress, each member of
- 22 Congress from Pennsylvania and to the Office of General Counsel
- 23 of the United States Department of Transportation at 1200 New
