A RESOLUTION

Directing the Joint State Government Commission to conduct an 1 assessment and analysis of public and private recycling 2 infrastructure and operations across the Commonwealth. 3 WHEREAS, Investment in a Statewide recycling strategy through 4 programs that encourage uniform, life-cycle-focused product 5 stewardship efforts at the producer level is essential; and 6 7 WHEREAS, Pennsylvania has a vibrant and robust economy 8 related to the production of packaging, which supports thousands 9 of good-paying jobs across our communities; and 10 WHEREAS, Many, if not all, of these products can be recycled at the end of their life, decreasing our collective dependence 11 on virgin materials and increasing the consumption of recycled 12 13 materials, ideally moderating environmental impacts in the 14 process; and 15 WHEREAS, Operations necessary to collect, sort and process

some of these materials lag behind the volume of materials

consumers use, resulting in their unfortunate diversion to

- 1 landfills; and
- 2 WHEREAS, Increased investment in recycling infrastructure
- 3 assists in reversing the trend toward using landfills; and
- 4 WHEREAS, Education of consumers on recycling and new
- 5 recycling operations create good-paying jobs and promote
- 6 increased circularity in the interest of sustainability;
- 7 therefore be it
- 8 RESOLVED, That the Senate direct the Joint State Government
- 9 Commission to conduct an assessment and analysis of public and
- 10 private recycling infrastructure and operations across the
- 11 Commonwealth, including:
- 12 (1) consulting with representatives from a diverse array
- of backgrounds, including, but not limited to, State agency
- officials, nongovernmental organizations and industry experts
- from both the recycling and manufacturing communities;
- 16 (2) a review of recycling infrastructure investment
- strategies adopted by other states, including public-private
- partnerships, industry-managed product collection strategies
- and other legislative approaches to the management of
- 20 plastics and other recyclable products, particularly
- 21 packaging; and
- 22 (3) providing suggestions for statutory provisions to
- 23 promote environmental stewardship across this Commonwealth
- through public policy while avoiding unintended consequences
- 25 experienced by other jurisdictions;
- 26 and be it further
- 27 RESOLVED, That the Joint State Government Commission issue a
- 28 report of its findings, along with any statutory or regulatory
- 29 recommendations, to the General Assembly within seven 12 months <--
- 30 of the adoption of this resolution.
