1 2 3 4 5 6 7 8	Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," in preliminary provisions, further providing for definitions; in safe schools, establishing the School Student Mental Health Assistance Augmentation Account; and making a repeal.
9	The General Assembly of the Commonwealth of Pennsylvania
10	hereby enacts as follows:
11	Section 1. Section 102 of the act of March 10, 1949 (P.L.30,
12	No.14), known as the Public School Code of 1949, is amended by
13	adding definitions to read:
14	Section 102. DefinitionsWhen used in this act the
15	following words and phrases shall have the following meanings:
16	* * *
17	"School psychologist." An individual who holds a valid
18	certificate for school psychologist issued by the Department of
19	Education which qualifies the individual to be employed by and
20	work within a school entity.

1	"School social worker." An individual who:
2	(1) holds an educational specialist certificate for school
3	social workers issued by the Department of Education;
4	(2) meets the exception for a school social worker as
5	provided under section 20(a.1) of the act of July 9, 1987
6	(P.L.220, No.39), known as the "Social Workers, Marriage and
7	Family Therapists and Professional Counselors Act"; or
8	(3) holds either a social worker license issued by the
9	Department of State or another certificate issued by the
10	Department of Education prior to the Department of Education's
11	development of an educational specialist certificate for school
12	social workers.

14	Section 2. The act is amended by adding a section to read:
15	Section 1302.2-A. School Student Mental Health Assistance
16	Augmentation Account(a) The School Student Mental Health
17	Assistance Augmentation Account is established as a restricted
18	receipts account within the General Fund.
19	(b) Notwithstanding 42 Pa.C.S. § 3733(a.1)(2)(iii) (relating
20	to deposits into account), for the fiscal year 2023-2024 and
21	each fiscal year thereafter, \$8 of each additional fee imposed
22	under 42 Pa.C.S. § 3733(a.1)(1) shall be deposited into the
23	account and \$2 of each additional fee shall be deposited into
24	the Access to Justice Account.
25	(c) Money deposited into the account is appropriated on a
26	continuing basis to the Department of Education for distribution
27	under subsection (d).
28	(d) All money deposited into the account shall be used for
29	the purpose of providing grants to school entities to support
30	
30	school-linked mental health services. The Department of

1	Education shall, upon written application and subsequent	
2	approval, grant money from the account to a school entity.	
3	Allowable grant activities and related expenses include:	
4	(1) Employing and retaining one of the following mental	
5	health professionals:	
6	(i) A school counselor.	
7	(ii) A school psychologist.	
8	(iii) A school social worker.	
9	(2) Providing mental health services and transportation for	
10	students receiving school-linked mental health services.	
11	(e) The Department of Education shall establish grant	
12	application review procedures and shall prioritize grant funding	
13	for activities and related expenses under subsection (d)(1).	
14	(f) Grant money allocated through the account shall be used	
15	to supplement and not supplant existing school entity spending	
16	on mental health professionals.	
17	(g) The Department of Education shall promulgate rules and	
18	regulations as necessary to administer this section.	
19	(h) As used in this section, the following words and phrases	
20	shall have the meanings given to them in this subsection unless	
21	the context clearly indicates otherwise:	
22	"Account." The School Student Mental Health Assistance	
23	Augmentation Account established under subsection (a).	
24	"School counselor." An individual who holds a valid	
25	certificate for Elementary and Secondary School Counselor issued	
26	by the Department of Education which qualifies the individual to	
27	be employed by and working within a school entity.	
28	"School entity." A school district, charter school, regional	
29	charter school, cyber charter school, intermediate unit or area	
30	career and technical school operating within this Commonwealth.

Section 3. The provisions of 42 Pa.C.S. § 3733(a.1)(2)(iii)
are repealed insofar as they are inconsistent with the addition
of section 1302.2-A of the act.

4 Section 4. This act shall take effect July 1, 2023, or 5 immediately, whichever is later.
