AN ACT

1 Amending Titles 18 (Crimes and Offenses), 42 (Judiciary and  
2 Judicial Procedure) and 53 (Municipalities Generally) of the  
3 Pennsylvania Consolidated Statutes, in assault, further  
4 providing for ethnic intimidation; in employees, further  
5 providing for definitions and providing for police officer  
6 training on hate-based intimidation; and making an editorial  
7 change.

8 The General Assembly of the Commonwealth of Pennsylvania  
9 hereby enacts as follows:

10 Section 1. Section 2710 heading, (a) and (c) of Title 18 of  
11 the Pennsylvania Consolidated Statutes, amended by the act of  
12 December 3, 2002 (P.L.1176, No.143), declared unconstitutional,  
13 936 A.2d 188 (Pa. Commonwealth 2007), affirmed, 951 A.2d 345  
14 (2008), are amended and the section is amended by adding a  
15 subsection to read:

16 § 2710. [**Ethnic**] Hate-based intimidation.

17 (a) Offense defined.--A person commits the offense of  
18 [**ethnic intimidation if, with malicious intention toward the**

1 race, color, religion or national origin of another individual  
2 or group of individuals, he commits an offense under any other  
3 provision of this article or under Chapter 33 (relating to  
4 arson, criminal mischief and other property destruction)  
5 exclusive of section 3307 (relating to institutional vandalism)  
6 or under section 3503 (relating to criminal trespass) with  
7 respect to such individual or his or her property or with  
8 respect to one or more members of such group or to their  
9 property.] hate-based intimidation if both of the following

10 occur:

11 (1) The person commits any of the following offenses:

12 (i) a personal injury crime as defined in section  
13 103 of the act of November 24, 1998 (P.L.882, No.111),  
14 known as the Crime Victims Act;

15 (ii) an offense under Chapter 33 (relating to arson,  
16 criminal mischief and other property destruction),  
17 exclusive of section 3307 (relating to institutional  
18 vandalism); or

19 (iii) an offense under section 3503 (relating to  
20 criminal trespass).

21 (2) The person intentionally selected the person against  
22 whom the offense under paragraph (1) was committed or the  
23 property that was damaged or otherwise affected, in whole or  
24 in substantial part, because of the actual or perceived race,  
25 color, religion, national origin, ethnicity, ancestry, sex,  
26 gender, gender identity, gender expression, sexual  
27 orientation or disability of an individual or group of  
28 individuals.

29 (b.1) Construction.--Nothing in this section may be  
30 construed to prohibit, limit or punish religiously motivated

1 speech or conduct that is otherwise protected by the  
2 Constitution of the United States, the Constitution of  
3 Pennsylvania or the act of December 9, 2002 (P.L.1701, No.214),  
4 known as the Religious Freedom Protection Act.

6 [(c) Definition.--As used in this section "malicious  
7 intention" means the intention to commit any act, the commission  
8 of which is a necessary element of any offense referred to in  
9 subsection (a) motivated by hatred toward the race, color,  
10 religion or national origin of another individual or group of  
11 individuals.]

12 Section 2. Section 8309(a) introductory paragraph of Title  
13 42 is amended to read:

14 § 8309. Civil rights violations.

15 (a) Redress for personal injury.--A person who incurs injury  
16 to his person or damage or loss to his property as a result of  
17 conduct described in 18 Pa.C.S. § 2710 (relating to [ethnic]  
18 hate-based intimidation) or 3307 (relating to institutional  
19 vandalism) shall have a right of action against the actor for  
20 injunction, damages or other appropriate civil or equitable  
21 relief. In the action, the issue of whether the defendant  
22 engaged in the conduct alleged shall be determined according to  
23 the burden of proof used in other civil actions for similar  
24 relief. The plaintiff may seek recovery for any of the  
25 following:

27 Section 3. Section 2162 of Title 53 is amended by adding a  
28 definition to read:

29 § 2162. Definitions.

30 The following words and phrases when used in this subchapter

1 shall have the meanings given to them in this section unless the  
2 context clearly indicates otherwise:

4 "Hate-based intimidation." An offense specified under 18  
5 Pa.C.S. § 2710 (relating to hate-based intimidation).

6 \* \* \*

7 Section 4. Title 53 is amended by adding a section to read:  
8 § 2173. Police officer training on hate-based intimidation.

9 The commission and the Pennsylvania State Police shall, in  
10 consultation with the Pennsylvania Human Relations Commission  
11 and the Attorney General, develop and provide biennial training  
12 on hate-based intimidation to police officers. The commission  
13 and the Pennsylvania State Police may also consult with relevant  
14 stakeholders in developing the training. The training shall  
15 include, but not be limited to:

16 (1) Identification of hate-based intimidation.

17 (2) Methods to address hate-based intimidation.

18 (3) Reporting of hate-based intimidation.

19 (4) Hate-based intimidation recordkeeping.

20 Section 5. This act shall take effect in 60 days.
