## AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, in licensing of drivers, further providing for 1

- § 1506. Application for driver's license or learner's permit.
- 10 (a) Form and content. -- Every application for a learner's
- 11 permit or driver's license shall be made upon a form furnished
- by the department and shall contain such information as the 12
- 1.3 department may require to determine the applicant's identity,
- 14 competency and eligibility. The form [may] shall also provide
- 15 for inclusion of personal medical information, next of kin
- 16 <u>information</u> and other information of use in an emergency[.], but
- an applicant may not be required to include personal medical 17
- information, next of kin information or other information of use 18

- 7 (c) Reports to coroner. -- The Office of Administration shall
- 8 create a uniform process that provides coroners, as defined in
- 9 <u>section 1202-B of the act of August 9, 1955 (P.L.323, No.130),</u>
- 10 known as The County Code, acting within their official duties
- 11 access to the following records and systems in the Pennsylvania
- 12 <u>Justice Network (JNET)</u>, or its successor, at no cost:
- (1) Emergency contact or next of kin information
- 14 provided by an individual at the time of application under
- 15 <u>section 1506(a) (relating to application for driver's license</u>
- or learner's permit).
- 17 (2) Anatomical organ donor registration status as
- indicated on an individual's driver's license or
