## AN ACT

Amending the act of April 12, 1951 (P.L.90, No.21), entitled "An 1 act relating to alcoholic liquors, alcohol and malt and 2 brewed beverages; amending, revising, consolidating and 3 changing the laws relating thereto; regulating and 4 restricting the manufacture, purchase, sale, possession, 5 consumption, importation, transportation, furnishing, holding 6 in bond, holding in storage, traffic in and use of alcoholic 7 liquors, alcohol and malt and brewed beverages and the 8 9 persons engaged or employed therein; defining the powers and duties of the Pennsylvania Liquor Control Board; providing 10 for the establishment and operation of State liquor stores, 11 for the payment of certain license fees to the respective 12 municipalities and townships, for the abatement of certain 13 nuisances and, in certain cases, for search and seizure 14 without warrant; prescribing penalties and forfeitures; 15 providing for local option, and repealing existing laws," in 16 licenses and regulations and liquor, alcohol and malt and 17 brewed beverages, further providing for unlawful acts 18 relative to liquor, malt and brewed beverages and licensees. 19 20 The General Assembly of the Commonwealth of Pennsylvania 21 hereby enacts as follows: 22 Section 1. Section 493(13) of the act of April 12, 1951 23 (P.L.90, No.21), known as the Liquor Code, is amended to read: 24 Section 493. Unlawful Acts Relative to Liquor, Malt and 25 Brewed Beverages and Licensees. -- The term "licensee," when used in this section, shall mean those persons licensed under the 26

provisions of Article IV, unless the context clearly indicates
otherwise.

3 It shall be unlawful--

(13) Retail Licensees Employing Minors. For any hotel, 5 6 restaurant or club liquor licensee, or any retail dispenser, to 7 employ or to permit any minor under the age of eighteen to serve 8 any alcoholic beverages or to employ or permit any minor under the age of sixteen to render any service whatever in the 9 10 licensed premises, nor shall any entertainer under the age of eighteen be employed or permitted to perform in any licensed 11 premises in violation of the labor laws of this Commonwealth: 12 13 Provided, That in accordance with board regulations minors 14 between the ages of sixteen and eighteen may be employed to 15 serve food, clear tables and perform other similar duties, not 16 to include the dispensing or serving of alcoholic beverages. A ski resort, golf course or amusement park licensee may employ 17 18 minors between the ages of fourteen and fifteen [years of age] 19 to perform duties in rooms or areas of the licensed premises; 20 however, such minors may not perform duties in rooms or areas in which alcohol is being concurrently dispensed or served or in 21 which alcohol is being concurrently stored in an unsecured 22 23 manner. Notwithstanding any provision of law to the contrary, an\_ 24 organization established as a nonprofit organization under 26 U.S.C. § 501(c)(3) (relating to exemption from tax on 25 26 corporations, certain trusts, etc.), operating in a city of the second class or a county of the second class and providing\_ 27 28 educational programming designed to provide culinary and life 29 skills, together with support services and resources, to criminal justice system-involved juveniles and young adults may 30

1 employ minors between the ages of fifteen and eighteen to serve food, clear tables and perform other similar duties, not to 2 include the dispensing or serving of alcoholic beverages. 3 Notwithstanding any provisions of law to the contrary, a hotel, 4 restaurant or club liquor licensee or any retail dispenser may 5 allow students receiving instruction in a performing art to 6 perform an exhibition if the students are not compensated and 7 are under proper supervision. Written notice of the performance 8 9 must be provided to the enforcement bureau prior to the 10 performance.
