A CONCURRENT RESOLUTION

1 2 3 4	Establishing the Pennsylvania State Song Commission to study the history of the State song of the Commonwealth, solicit submissions for a new State song and recommend changes to the State song.
5	WHEREAS, During the 1987-1988 legislative session, the chair
6	of the House State Government Committee led a committee tasked
7	with recommending a State song for the Commonwealth; and
8	WHEREAS, The committee was composed of representatives from
9	the Pennsylvania Music Educators Association, the Pennsylvania
10	Council on the Arts, professional musicians and members of the
11	public; and
12	WHEREAS, After receiving hundreds of song submissions from
13	the public, the committee selected the song "Pennsylvania" by
14	Eddie Khoury and Ronnie Bonner; and
15	WHEREAS, The act of November 29, 1990 (P.L.598, No.150),
16	referred to as the Official State Song Act, adopted the song
17	"Pennsylvania" as the official State song of the Commonwealth;

19	WHEREAS, It is in the interest of this Commonwealth to adopt

a State song that represents the culture, history, spirit and 1 2 people of Pennsylvania; therefore be it 3 RESOLVED (the Senate concurring), That the General Assembly establish the Pennsylvania State Song Commission to study the 4 history of the State song of the Commonwealth, solicit 5 6 submissions for a new State song and recommend changes to the 7 State song; and be it further 8 RESOLVED, That the commission consist of the following 9 members: 10 one member appointed by the Majority Leader of the (1)11 Senate; 12 one member appointed by the Minority Leader of the (2) 13 Senate; 14 one member appointed by the Majority Leader of the (3) House of Representatives; 15 16 one member appointed by the Minority Leader of the (4) House of Representatives; 17 18 (5) one representative from the Pennsylvania Music 19 Educators Association; 20 (6) one representative from the Pennsylvania Council on 21 the Arts; (7) one representative from the American Federation of 22 Musicians who, at the time of the formation of the 23 24 commission, resides in this Commonwealth; and 25 (8) two members of the public appointed by the Governor; 26 and be it further 27 RESOLVED, That the commission hold its first meeting within 28 60 days of the adoption of this resolution and meet no less than 29 quarterly thereafter; and be it further 30 RESOLVED, That at its first meeting, the commission elect one

1 member to serve as chair of the commission; and be it further
2 RESOLVED, That the commission has the authority to add
3 additional members to the commission and create subgroups within
4 the commission as it sees fit; and be it further

5 RESOLVED, That the commission seek comments and submissions 6 from the public on recommendations for a new State song; and be 7 it further

8 RESOLVED, That the commission choose a song, or songs, to 9 recommend to the General Assembly to become the new State song; 10 and be it further

11 RESOLVED, That the members of the commission serve without 12 compensation but be reimbursed for all necessary and reasonable 13 expenses incurred in the performance of their duties; and be it 14 further

RESOLVED, That reasonable expenses incurred by the commission be equally divided between the Senate and the House of Representatives; and be it further

18 RESOLVED, That the approval of the President pro tempore of 19 the Senate and the Speaker of the House of Representatives be 20 required to preauthorize all proposed actions of the commission that will entail the expenditure of State funds and approve all 21 expenditures, including expense reimbursement requests of 22 23 commission members, prior to payment; and be it further 24 RESOLVED, That nothing in this concurrent resolution preclude 25 the commission from consulting or seeking the expertise of any 26 individual, nonprofit entity, Commonwealth agency or office or legislative committee of the General Assembly to aid with the 27 28 selection of a new State song; and be it further 29 RESOLVED, That the commission issue a final report with its 30 findings and recommendations to the General Assembly within 12
