- 20 BACCALAUREATE DEGREE.
- 21 (3) EVIDENCE OF A MINIMUM OF EIGHT THOUSAND (8,000) HOURS,
- 22 EQUIVALENT TO FOUR (4) YEARS FULL-TIME, AS A VOLUNTEER
- 23 FIREFIGHTER OR EMERGENCY MEDICAL TECHNICIAN IN THE OCCUPATIONAL
- 24 AREA TO BE TAUGHT.

- 30 (f) As used in this section, the following words and phrases

- 1 shall have the meanings given to them in this subsection unless
- 2 the context clearly indicates otherwise:
- 3 "Emergency medical technician" shall mean an individual who
- 4 <u>is certified by the Department of Health as an emergency medical</u>
- 5 technician.
- 6 <u>"Satisfactory achievement" shall mean an acceptable level of</u> <--
- 7 performance as determined by the State Board of Education on the
- 8 department prescribed assessments required under 22 Pa. Code Ch.
- 9 49 (relating to certification of professional personnel).
- 10 "Volunteer firefighter" shall mean as follows:
- 11 (1) A person who is a member of:
- 12 (i) a fire company organized and existing under the laws of
- 13 this Commonwealth;
- 14 (ii) a fire police unit, rescue squad, ambulance corps or
- 15 other like organization affiliated with one or more fire
- 16 <u>companies; or</u>
- 17 (iii) a fire company or affiliated organization which
- 18 participates in the fire service but does not look to that
- 19 service as his or her primary means of livelihood.
- 20 (2) A person does not lose status as a volunteer firefighter
- 21 solely because he or she may also be a paid firefighter, so long
- 22 <u>as the person is acting within the scope of his or her</u>
- 23 responsibilities as a member of a volunteer fire company at the
- 24 pertinent time and not within the scope of his or her
- 25 responsibilities as a paid firefighter.
- 26 Section 2. The provisions of 22 Pa. Code §§ 49.142(a)(1) and <--
- 27 49.151(b) are abrogated.
- 28 Section 3 2. This act shall take effect in 60 days. <--
