An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school districts, further providing for how constituted. (Representatives MUSTELLO, STRUZZI, ROWE and others) - **Education, March 17, 2021** 8

OVER

This bill amends the Public School Code to permit a school district to change its name.

An Act amending the act of April 9, 1929 (P.L.343, No.176), known as The Fiscal Code, in emergency finance and tax provisions, providing for exemption from taxation. (Representatives MARKOSEK, HILL-EVANS, A. DAVIS and others) - **Finance, February 26, 2021** 12

OVER

This bill amends the Fiscal Code to exclude economic recovery payments issued under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from consideration as income, earned income or taxable income.

This bill amends the Tax Reform Code to exclude an amount of loan forgiveness granted under the Federal Coronavirus Aid Act or the Federal Consolidated Appropriations Act, 2021, from state income tax.

This bill eliminates the Property Tax Penalty if property tax bill is not received during the first year of ownership.

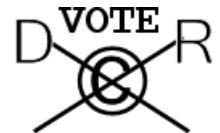
