OVERVIEW:

House Bill 2291 provides for the Capital Budget Project Itemization Act of 2010/11. The Capital Facilities Debt Enabling Act provides the framework for the capital budget process in Pennsylvania, including the setting of annual debt limits under the Capital Budget Act and the itemization of projects under the Capital Budget Project Itemization Act.

It also establishes the categories under which capital projects may be state funded, in part or in whole, through the issuance of general obligation debt or current revenue. The categories in House Bill 2291 are: Public Improvements; Furniture and Equipment, Transportation Assistance; Redevelopment Assistance; Flood Control; Keystone Recreation, Park, and Conservation Fund; Environmental Stewardship; State Forestry Bridge; General Fund Current Revenue Projects; State ATV/Snowmobile Fund Projects; State Transportation Enhancement Projects; and State Stores Fund Current Revenue Projects.

This act shall take effect immediately.

ANALYSIS:

The total authorization for Public Improvements Projects is \$3,839,809,000 for projects to be acquired or constructed by the Department of General Services, its successors or assigns, to be financed by the incurring of debt.

The total authorization for Furniture and Equipment Projects is \$194,321,000 for projects consisting of the acquisition of original movable furniture and equipment to complete public improvement projects to be acquired by the Department of General Services, its successors or assigns, to be financed by the incurring of debt.

The total authorization for Transportation Assistance Projects is \$1,041,742,500 for projects to be acquired in or constructed by the Department of Transportation to be financed by the incurring of debt.

The total authorization for Redevelopment Assistance Capital Projects is \$7,375,792,000 for capital grants by the Department of Community and Economic Development, its successors or assigns, to be financed by the incurring of debt.

The total authorization for Flood Control Projects is \$80,445,000 for projects to be constructed by the Department of Environmental Protection, its successors or assigns, to be financed by the incurring of debt.

The total authorization for Keystone Recreation, Park and Conservation Projects is \$51,825,000 for projects to be constructed by the Department of Conservation and Natural Resources, its successors or assigns, to be financed from current revenues in the Keystone Recreation, Park and Conservation Fund.

The total authorization for Environmental Stewardship Fund Projects is \$20,050,000 for projects to be constructed by the Department of Conservation and Natural Resources, its successors or assigns, to be financed from current revenues in the Environmental Stewardship Fund.

The total authorization for State Forestry Bridge Projects is \$11,605,000 for projects to be constructed by the Department of Conservation and Natural Resources, its successors or assigns, to be financed by Oil Company Franchise tax revenues pursuant to 75 PA.C.S. § 9502(A) (2) (IV) (relating to imposition of tax).

The total authorization for General Fund Current Revenue Projects is \$24,150,000 for projects to be constructed by the Department of General Services, its successors or assigns, to be financed from current revenues in the General Fund.

The total authorization for State ATV/Snowmobile Fund Projects authorizes \$300,000 for projects to be constructed by the Department of Conservation and Natural Resources, its successors or assigns, to be financed from current revenues in the State ATV/Snowmobile Fund.

The total authorization for State Transportation Enhancement Projects is \$5,000,000 for projects to be constructed by the Department of Conservation and Natural Resources, its successors or assigns, to be financed from current revenues from state transportation enhancement funds.

The total authorization for State Stores Fund Current Revenue Projects is \$552,000 for capital projects in the category of public improvements and to be developed by the Department of General Services for the Pennsylvania Liquor Control Board, to be financed from the current revenues of the State Stores Fund.

House Bill 2291 authorizes a total of \$12,645,591,500 for projects across the above mentioned categories. Of that amount, up to \$12,532,109,500 can be financed by the sale of bonds. The additional cost to the Commonwealth cannot be determined at this time, since project funding decisions have yet to be made and the interest rate on the bonds will be determined at the time of sale.
