**SUMMARY**: Creates the Primary Stroke Center Recognition Act establishing a statewide stroke system of care by recognized stroke centers and the training/transport protocols for emergency medical services providers. The effective date is in 60 days.

**ANALYSIS**: This legislation would require the Department of Health to recognize a licensed acute care hospital as a primary stroke center if the hospital is certified as a primary stroke center by the Joint Commission or another nationally recognized accrediting organization that provides certification for stroke care. The designation would remain in effect for as long as the hospital remains certified as a primary stroke center. The department would also be required to make available a list of accredited primary stroke centers to each emergency medical services agency medical director and to distribute a nationally recognized standardized stroke triage assessment tool; to establish protocols related to prehospital assessment, treatment and transport of stroke patients by licensed emergency medical services providers; to establish protocols to ensure certified emergency medical services providers within their scope of practice receive regular training on assessment/treatment of stroke patients; and to prepare/file a biennial report by July 1 in odd numbered years in conjunction with its review of emergency medical services providers protocols. The legislation would require that, within 60 days of the effective date, each emergency medical services provider is in compliance with all protocols and promulgated regulations.

**FISCAL IMPACT**: Enactment of this legislation would have no adverse fiscal impact on Commonwealth funds; this estimate assumes that any cost that might be associated with implementation could be absorbed by the department.
