SUMMARY: Amends the Constitution of Pennsylvania providing for equality of rights because of race and ethnicity, concurrent orders and resolutions, and for disaster emergency declaration and management.

ANALYSIS: This legislation proposes three separate amendments to the Constitution of Pennsylvania as follows:

Article I: This resolution adds a new section that would prohibit denying or abridging equality of rights under the law in the Commonwealth of Pennsylvania because of the race or ethnicity of an individual.

Section 9 of Article III: This resolution would add a provision allowing for non-presentment to the governor of a Joint Resolution terminating or extending a declaration of disaster emergency.

Article IV: This resolution adds a new section that would authorize the Governor to issue emergency declarations under circumstances provided for by law for that purpose. The General Assembly could by law grant the Governor certain enumerated powers to address and abate the declared emergency. However, a declaration by the Governor of an emergency could not last longer than 21 days unless extended by a concurrent resolution of the General Assembly approving the continuation of the declaration. Upon the expiration of the Governor's emergency declaration, the Governor could not declare a new state of emergency based upon the same or substantially similar facts and circumstances without the passage of a concurrent resolution of the General Assembly expressly approving the new emergency declaration.

Effective Date: This legislation would be required to pass in two consecutive legislative sessions. Upon passage in the second consecutive legislative session, the Secretary of the

Commonwealth would be required to submit the proposed constitutional amendment to the qualified electors of the Commonwealth at the first primary, general or municipal election which occurs at least three months after the proposed constitutional amendment is passed by the General Assembly.

FISCAL IMPACT: Article XI, Section 1, of the Constitution of the Commonwealth of Pennsylvania requires that a joint resolution proposing to amend the Constitution be passed by the General Assembly in two consecutive legislative sessions, be advertised in two newspapers in each county after each passage and thereafter be approved by the electorate.

According to the Department of State, costs for the first round of three, monthly advertisements prior to an election range between \$500,000 and \$1,000,000. The Department indicates that all three of these amendments could likely be included in one advertisement.
