SUMMARY: House Bill 2657, printer's number 3214, makes appropriations from the Public School Employees' Retirement Fund and from the PSERS Defined Contribution Fund to provide for expenses of the Public School Employees' Retirement Board for the fiscal year July 1, 2022, to June 30, 2023, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2022.

ANALYSIS & FISCAL IMPACT: This bill makes an appropriation of \$55,467,000 from the Public School Employees' Retirement Fund to provide for the expenses incurred by the Public School Employees' Retirement Board for the administration of the system for the fiscal year beginning July 1, 2022, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2022.

Additionally, the bill appropriates \$949,000 from the PSERS Defined Contribution Fund restricted revenue account to provide for the expenses incurred by the Public School Employees' Retirement Board for the administration of the defined contribution plan authorized by Act 5 of 2017 for the fiscal year beginning July 1, 2022, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 2022.

The act shall take effect July 1, 2022, or immediately, whichever is later.
