DESCRIPTION AND PURPOSE OF BILL

House Bill 2292 provides for the Commonwealth's nonpreferred appropriation to the Pennsylvania State University for FY 2010-11. The bill also appropriates money from the Federal ARRA State Fiscal Stabilization Fund (SFSF) to the University to ensure its previous year funding level is maintained.

FISCAL NOTE

The bill specifies \$319,564,000 shall be provided for General Support, which includes \$304,449,000 in state funds and \$15,115,000 in Federal ARRA SFSF funds. Additionally, \$14,229,000 is provided for Penn College of Technology, which includes \$13,623,000 in state funds and \$676,000 in Federal ARRA SFSF funds.

Payments to the University are to be made in equal amounts on a monthly basis and the bill is scheduled to take effect July 1, or immediately, whichever is later.

FISCAL IMPACT:

The bill appropriates a total of \$333,863,000 in funds to the University in FY 2010-11. State funds amount to \$318,072,000 and Federal ARRA SFSF funds amount to \$15,791,000.
