**DESCRIPTION**

House Bill 1210 amends the Public School Code to repeal provisions that are outdated and no longer necessary.

The provisions repealed by the legislation are as follows:

- Section 112 (relating to report of racial and ethnic groupings);
- Section 113 (relating to study of public schools that provide internet instruction);
- Section 212 (relating to corporate seal);
- Section 292 (relating to submission of plans);
- Section 294 (relating to disapproval of plans);
- Section 295 (relating to department of public instruction to prepare plans);
- Section 296 (relating to establishment of reorganized school districts);
- Section 297 (relating to advance establishment);
- Section 510.1 (relating to special school watchmen-school districts in townships of the second class);
- Section 519 (relating to copies of school laws);
- Section 523(a) (relating to educational broadcasting);
- Section 705 (relating to residences for teachers and janitors);
- Section 736 (relating to heating stoves to be shielded);
- Section 737 (relating to ventilation; thermometer);
- Section 738 (relating to fireproof construction);
- Section 739 (relating to doors to open outward; fire escapes; etc.);
- Section 760 (relating to completion of abandoned WPA projects, districts third and fourth class);
- Section 772 (relating to condition of grounds; shade trees);
- Section 1208 (relating to summer schools, etc.);
- Section 1317.1 (relating to possession of telephone pagers prohibited);
- Section 1337(f) (relating to studies, appraisals and reports to Governor in nonprofit school food programs);
- Section 1338.2 (relating to antitruancy programs);
- Section 1378 (relating to medical care for children under six with defective hearing);
- Section 1308-A (relating to report);
- Section 1414 (relating to care and treatment of pupils);
- Section 1422.1 (relating to local wellness policy);

- Section 1522 (relating to foreign language academies);
- Section 1534 (relating to monthly reports to school directors; districts second, third and fourth class);

- Section 1811 (relating to estimate of expenses and reimbursements; appropriations);

The bill is scheduled to take effect in 60 days.

### **FISCAL IMPACT:**

The enactment of House Bill 1210 will have no impact on Commonwealth funds as it repeals outdated provisions of the law that are no longer necessary.
