Co-sponsorship of Legislation to Prohibit Text Messaging Intragovernmental Council **SUBJECT:** 

While Driving

December 9, 2010 DATE:

In the near future, I will be introducing legislation prohibiting the act of text messaging while driving. This legislation would make violation of the texting ban a primary offense for all Pennsylvania drivers, and includes a fine of not less than \$50 and not more than \$100, as well as an assessment of one point on the driver's record.

Texting while driving is a growing problem that U.S. Department of Transportation Secretary Ray LaHood now calls "a menace to society." According to USDOT research, 6,000 people a year die as a result of accidents caused by distracted drivers. The act of "texting" causes a driver to take his/her eyes off the road and hands off the wheel; there is a large body of evidence that validates texting while driving as the most dangerous form of distracted driving. Virginia Tech's Transportation Institute conducted several large distracted driving studies and concluded that the risk of a crash by a driver who is texting is 23 times higher than the risk faced by a non-distracted driver.

Thirty states already have enacted legislation banning texting while driving. Therefore, I am asking that Pennsylvania respond to the national consensus on the issue. Please consider:

- A 2009 New York Times/CBS News poll indicated that 97 percent of Americans support a prohibition on texting while driving.
- A 2009 national survey by AAA indicated that 87 percent of drivers consider texting while driving to be "a very serious threat" to their personal safety.
- In January of 2009, the National Safety Council called on state and federal lawmakers to ban texting while driving.

This legislation will save lives. There have been far too many tragic stories of drivers who have been killed or who have accidentally killed others because they made the fatal mistake of texting while driving.
