

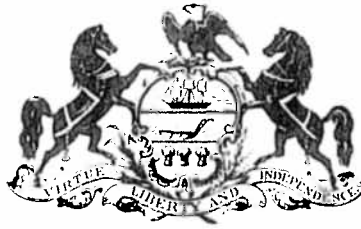

Subject: Co-sponsor – Re-introduction of HB 2749
**LAND EXCHANGE – DCNR & KYLE AND TAMARA
BOLTZ, LEBANON COUNTY**

I plan to re-introduce HB 2749 to authorize a land exchange between DCNR and my constituents, Kyle and Tamara Boltz in Lebanon County.

The legislation will authorize the exchange of two parcels of land in the vicinity of Lickdale, Lebanon County. The Department of Conservation and Natural Resources, Bureau of State Parks will transfer 4.191 acres of Swatara State Park to Kyle A. and Tamara J. Boltz. In return, Kyle A. and Tamara J. Boltz will transfer 11.908 acres of private property to the Department. In addition, Kyle A. and Tamara J. Boltz will transfer a utility, vehicular, and pedestrian easement, which totals approximately 1.5 acres. This exchange of lands is needed to develop Phase 1 of DGS project number 152-2. In addition, the land exchange will allow for the citizens of Pennsylvania to have access to the Swatara Creek in the vicinity of Lickdale, Lebanon County.
