Co-sponsorship Legislation – Early Voting

Former House Bill 46 of 2009-2010

In the near future, I plan to re-introduce legislation that would amend the Pennsylvania Election Code to allow for early voting in the Commonwealth.

Early voting permits electors to vote on a single or series of days prior to an election. My bill would allow qualified individuals to vote at designated polling places in their election districts beginning ten days before a general, municipal, or primary election. Major benefits of early voting include increased participation, which is the main goal of this legislation by making voting more convenient for electors. It also lowers costs. Secondly, early voting can fit into voters' schedules more easily and can alleviate the long lines and overtaxed poll-workers that have become problematic on Election Day.
