**RE:** Co-sponsorship of Legislation - Pennsylvania Public Integrity Commission Act

In the near future we plan to re-introduce legislation to create a Public Integrity Commission. All of us are aware, over the last few years, of the numerous allegations, ongoing court cases and convictions related to public corruption in the Commonwealth. These corruption cases have involved both local and state officials and have touched on the legislative, judicial and executive branches of government. All of us work under the shadow of this corruption and experience the impact on the public's perception of its government.

To address and prevent corruption, we believe that the public would be best served by a statewide law enforcement entity which focuses on investigating criminal incidents of public corruption. In the near future, we intend to introduce legislation to create the Pennsylvania Public Integrity Commission. Its mission would be to:

- Uncover and investigate public corruption at all levels and in all branches of government within the Commonwealth. Investigations would be referred to appropriate law enforcement officials for prosecution.
- Serve both a law enforcement and educational role with respect to corruption in Pennsylvania.
- Work cooperatively with other law enforcement entities, including the Pennsylvania Attorney General.
- Issue reports on its work, the status of corruption and recommendations for reform.

The Public Integrity Commission would have subpoena power and the authority to seek immunity orders to obtain testimony necessary in public corruption investigations. This ensures it has maximum ability to carry out investigations.
