338	369	Would provide formal recognition of Native American Tribes in PA
341	372	Amends the School Code to provide for violence programs in schools
343	374	Providing for tax incentives for employers who provide child day-care services
344	375	Eliminates the statute of limitations to allow for unlimited time to bring civil and/or criminal actions (in child sexual abuse cases)
