**SUBJECT:** Co-sponsorship #3 - Ski Resort Liquor License

I am re-introducing legislation to amend the Liquor Code, allowing privately-owned ski resorts to be exempt from the retail liquor license quota. This exemption will enable the owners of these resorts to obtain a restaurant liquor license directly from the LCB.

Currently, the Liquor Code offers such exemptions to public venues, performing arts facilities, hotels, municipal golf courses, privately-owned private golf courses and privately-owned public golf courses from the quota requirement. My legislation includes ski resorts in the exemption category - if the resort offers downhill skiing with a minimum of 6 trails and an elevation of at least 400 hundred feet.

This legislation was SB 1324 of last session and co-sponsors were RAFFERTY, EARLL , BOSCOLA and STOUT.
