SUBJECT: Re- Introduction of Legislation

I intend to re-introduce the following pieces of legislation in the near future. I invite you to review these proposals and join me in cosponsoring any or all of the measures below. Former House Bill 389 – Medical Consent for a Minor - Amending Title 20 (Decedents, Estates and Fiduciaries), providing for medical consent for a minor by an adult caregiver.

Former House Bill 390 – School Health Services - Amending the Public School Code of 1949, providing for health services and for dental examinations and dental hygiene services.

Former House Bill 391 – Cremation Licensure – Amending the act of January 14, 1952 (1951 P.P. 1898, No. 522), known as the Funeral Director Law, regulating cremation.

Former House Bill 392 – Domestic Violence Employment Leave - An act requiring certain employers to provide employment leave for victims of domestic violence; prohibiting certain acts; and prescribing penalties.

Former House Bill 393 – Allow for Civil Claim for Damages Intercept - Amends Title 23 (Domestic Relations), providing for civil claim for damages intercept.

Former House Bill 394 – Requiring Disclosure of ATM Fees - Requiring certain financial institutions to post transaction fees for each automated teller machine transaction; and restricting transaction fees for automated teller machines.

Former House Bill 395 – Providing for More Accurate Allocation of Temporary Assistance to Needy Families (TANF) Benefits for Assistance Groups - Amending the Public Welfare code, further defining “assistance group” and providing for eligibility and determination of need related to recipients of temporary assistance to needy families.

Former House Bill 397 - Regulating the Use of Personal Credit Information in issuing Personal Lines of Insurance - An act relating to the use of credit information by carriers of personal lines insurance.

Former House Bill 398 – Amending Title 42 (Judiciary and Judicial Procedure), providing for limitations of criminal actions.

Former House Bill 399 - Educational Guardianship - Amending Title 20 (Decedents, Estates and Fiduciaries) of the Pennsylvania Consolidated Statutes, providing for educational guardianship.

Former House Bill 401 – Handgun Safety Standards - Amending Title 18 (Crimes and Offenses), providing a safety performance standard for the manufacture of handguns, for the forfeiture of certain handguns and for enforcement relating to a safety standard for handguns.
